## Prosecution Follows 2010 Neb. Gang Raid

OMAHA, Neb. (AP) -Eleven people arrested in a federal raid last fall in central Nebraska have been sentenced to a combined 106 years on gang- and drugrelated charges, according to the FBI special agent who oversaw the investigation.

Weysan Dun, who's in the FBI's Ómaha office, said two other men await sentencing in the raid and another suspect has been deemed mentally unfit for trial.

# **New Enzyme Plant In Blair Readies To**

# **Serve Market**

BLAIR, Neb. — The leading maker of the enzymes used to produce biofuels says the declining political support for ethanol hasn't diminished the long-term prospects for the industry making fuel from plants.

Novozymes plans to open a major new enzyme plant in eastern Nebraska next year to better serve the ethanol industry.

"It's a huge potential that's out there," said Adam Monroe, president of Novozymes' North American unit.

Monroe said he thinks the U.S. biofuel industry has grown up a great deal over the past decade, so he's not concerned about the end of the federal ethanol tax credit next year.

"It can now stand on its own two feet and compete," he said.

But Monroe said he thinks the government should continue to support the biofuels industry through policies like the renewable fuels standard, which will require 36 billion gallons of biofuels to be blended into gasoline by 2022, including 16 billion gallons of cellulosic ethanol.

Monroe said the ethanol industry has the potential to provide a much bigger share of the nation's fuel supply than the renewable fuels standard requires.

"It's a bigger solution than a lot of people realize," he said. The Renewable Fuels Association says the industry is now producing about 13.7 billion gallons of ethanol at more than 200 plants nationwide, which includes 25 plants in Nebraska. That's roughly 10 percent of the 138 billion gallons of gas that were used in the country last year.

Association spokesman Matt Hartwig said the industry is prepared for the end of the 4.5-cent per gallon tax credit ethanol has received for several years.

"Right now, ethanol is very cost-competitive with gasoline without the tax credits," Hartwig said.

Novozymes expects the new enzyme plant, which cost between \$160 million and \$200 million, to be completed sometime during the second quarter of next year. More than 200 construction workers are spending their days at the site south of Blair to meet that target.

About 56 full-time employees work at the plant already, but that number will grow toward 100 beginning early next year.

Enzymes are strings of protein that can serve as catalysts in many natural and manmade processes. The enzymes produced in Blair will break down the starch in corn or another feedstock, which is a vital part of ethanol production.

In addition to corn-based ethanol, Novozymes is also a player in the emerging cellulosic ethanol business and has been working with the nation's largest ethanol company, Poet

LLC, on a pilot cellulosic ethanol plant in Emmetsburg, Iowa. Cellulose is the woody material in branches and stems that makes plants hard, and the ethanol industry is developing ways to produce fuel from cellulose economically. Once the costs of cellulosic ethanol are similar to corn-based ethanol, companies will be able to produce ethanol from straw, corn stalks, wood pulp and other inedible agricultural leftovers.

Monroe said he expects to see the first wave of commercial cellulosic ethanol plants open in early 2013. And he predicted that cellulosic ethanol will initially cost about \$2 per gallon to produce, so it should be able to compete with gasoline.

Hartwig said it has taken longer for cellulosic ethanol plants to get going because of the recession that hit in 2008 just as cellulosic technology was emerging.

The design of the Blair plant reflects Novozymes' optimism about the biofuels industry. The plant has room to be expanded fivefold, and some of the infrastructure for expansion, like concrete foundations for future structures, is being built now

Blair plant manager Fred Reikowsky says the project has edule ev en though severe flooding along the Missouri River cut off barge traffic to the area. Reikowsky said Novozymes had brought in enough equipment before the flooding that workers were able to stay busy

## 2nd Person Dies In Omaha Shootings

OMAHA, Neb. (AP) — A second man has died in a spate of weekend shootings in Omaha.

Police say 19-year-old James Mun died Sunday afternoon. He showed up at a hospital about 3:30 a.m. Saturday with critical injuries from a gunshot wound.

Mun was among the victims in at least five shootings in the city in a two-day period. Police say 22-year-old Jacquaez Simmis was found dead and another man injured about 2:15 a.m. Saturday at a residence.

One person suffered a shooting-related wrist injury in another Saturday shooting and two people walked into hospitals early Sunday with injuries from separate shootings. Police say none of the injuries appear to be life threatening.

One of the victims has been arrested on outstanding warrants. No other arrests from the shootings have been announced.

### **Sturgis' Only Bowling Alley Closes**

STURGIS (AP) — The Black Hills city of Sturgis has lost its only bowling alley.

The Rapid City Journal reports that owner Kenny Price closed Buffalo Bill's Bowling Alley earlier this month, saying a decline in business has made it impossible to keep the lanes open.

Price says the alley used to have 56 leagues but is now down to less than 10.

Bowler Judy Spicer says the building was in bad shape and in need of repair, which is why many stopped using the facility.

Bowler Gerrie Fischer says a leaky roof was one of many problems.

Price. who bought the building about eight years ago, says it has been difficult to make the needed improvements due to the decline in business.

## Prison Parole Policies Under Review

SIOUX FALLS (AP) — Prison officials in South Dakota say they will alter parole policies in response to the killing of a 75-year-old woman in her Sioux Falls home.

Prosecutors plan to seek the death penalty for 41vear-old James McVay, accused in the July 2 death of Maybelle Schein. Police say McVay stabbed Schein to death and then stole her car as part of a scheme to drive to Washington, D.C., and kill President Barack Obama.

McVay was released on parole two days before Schein was killed.

The Sioux Falls Argus Leader reports that the Department of Correction's list of "system improvements" includes contacting additional law enforcement when certain high-risk offenders are paroled.

## **Traffic Stop Nets 15 Pounds Of Pot**

RAPID CITY (AP) — Two California residents are facing felony charges after authorities discovered 15 pounds of marijuana during a traffic stop on Interstate 90 near Wall.

Police say 26-year-old Marco Guttierez and 29-yearold Nancy Canas were arrested Thursday after a South Dakota Highway Patrol officer noticed that the front license plate on their vehicle was not properly displayed.

Guttierez and Canas are charged with possession of more than 10 pounds of marijuana, possession with the intent to distribute more than one pound of marijuana, and possession of drug paraphernalia.

Canas is also charged with driving with a suspended license

The Rapid City Journal reports that bond was set at \$100,000 each.

agencies. They faced a combination of federal and state charges in a crackdown on the violent East Side Locos gang, which authorities sav has ties to the international Surenos gang based in southern California.

All of the men lived in Grand Island and were either U.S. citizens or legal residents. Most are serving their time in federal prisons. One man was given probation.

Only one case went to trial, Assistant U.S. Attorney Susan Lehr told NTVV-TV. Plea deals were reached in the others. Lehr attributed that to the quality of the in-

vestigations in the so-called **Operation Pier Pressure.** At the time of the raid, officials said they hoped the

arrests, combined with additional enforcement efforts, would cripple the East Side Locos and diminish gang activity in the city of 50,000people 125 miles west of Omaha. Hall County Attorney

Mark Young told the Grand Island Independent that "the arrests had a significant effect on the upper echelon of that particular gang." He said the sweep was part of an ongoing focus on gangs in the area.

The shells of most buildings on the 37-acre complex have been completed, and workers are now assembling the filtration systems and storage tanks inside.

But in one building, rows of giant fermenting tanks remain exposed to the elements at the moment because construction workers are still installing the steel skin of that building.

An elevated network of pipes runs throughout the Novozymes complex connecting the buildings. Different pipes in that network will carry the water, glucose and air needed for fermentation and transport the enzymes through the production process.

The plant will grow microorganisms inside a series of sterile tanks until those organisms create the enzymes needed for ethanol production.

After the enzymes are created, Novozymes runs the product through a series of filters to remove moisture and the microorganisms.

What's left is a concentrated enzyme that can then be mixed to suit the needs of different customers. A blending facility is already operating at the Blair plant and mixing enzymes for customers.

The finished product leaves the site in semitrailer tanker trucks.

Blair was chosen for Novozymes' new plant because the plant will be close to the raw materials it needs and close to its customers. Plus, Nebraska offered relatively cheap electrical power for the plant.

The Blair plant will take over production of Novozymes' biofuel enzymes from the company's North Carolina plant. That facility will then focus on making enzymes for other uses, including detergents, food production and beer brewing.

Novozymes estimates that its products accounted for about 47 percent of the global enzyme market in 2010 and about 65 percent of the biofuel enzyme market.

Sales of biofuel enzymes account for about 18 percent of Novozymes' business.

Novozymes, which is based in Bagsvaerd, Denmark, employs about 5,400 people — half of them based in Denmark.

## **Daugaard Looks To Lure Calif. Firms**

SIOUX FALLS (AP) - Gov. Dennis Daugaard said he will emphasize South Dakota's favorable tax climate during a recruiting trip next month in southern California.

The Republican has scheduled meetings with up to 60 business executives Dec. 9 in San Diego County following the Western Governors' Association conference in Palm Springs.

Daugaard plans to tell the CEOs about South Dakota's lack of corporate, death or personal income taxes and how he believes his state's tax climate is well-suited for businesses.

'There's a compelling argument," Daugaard told the North County Times in California. "Pulling up stakes and moving thousands of miles, that's something one doesn't do without lots of forethought."

One of the gatherings is scheduled at PureForge, a startup company that specializes in motor vehicle brake systems. PureForge is looking to move to the Rapid City area in 2012, the newspaper reported.
