Court To Decide If Alleged Victim Has To Testify

OMAHA, Neb. — The Nebraska Supreme Court will decide whether an alleged victim of sexual assault in the state has the right to refuse to testify against the accused, or be compelled by a judge to testify under threat of jail.

The state's high court will hear arguments next month in the case of a 24-year-old woman ordered last spring by Lancaster County District Judge Paul Merritt to testify against the man accused of molesting her when she was 7, or spend 90 days in jail for refusing.

The woman, referenced only as "H.M." in court documents, was found in contempt in April when she refused to testify against Glen Riensche, of Lincoln, saying that doing so would cause her deep humiliation. The judge said the case hinged on her testimony, outweighing any shame she might feel.

The contempt order drew criticism from victims' groups like the Rape, Abuse & Incest National Network, which said judge's actions would make the criminal justice system even less attractive to rape victims who are already reluctant to report

An attorney for the woman argues that the lower court judge erred by ignoring state law, which says "when the matter sought to be elicited would tend to render the witness criminally liable or to expose him or her to public ignominy, the witness is not compelled to answer.

Instead of applying the law's plain meaning, the judge added a requirement to it that the privilege of declining to testify only applies if such testimony is not material to the case, Lincoln attorney Randall Wertz said in a brief submitted to the state Supreme Court.

"Forcing victims in sexual assault cases to testify is contrary to (state law) and bad public policy," Wertz wrote. "We, as a state and society, cannot have a policy that forces sexual assault victims to testify, as it will have the unintended effect of potential victims not wanting to subject themselves to mandatory testimony under threat of duress and contempt.

The Nebraska Attorney General's office counters that an 1896 U.S. Supreme Court decision is the authority in the matter. That decision found that if testimony of a witness might disgrace him, and the proposed evidence is material to the trial, "the great weight of authority is that he may be compelled to answer."

Black Friday Shoppers Camping Out In S.D.

SIOUX FALLS (AP) — Black Friday is still several hours away, but a handful of the most dedicated shoppers have been in line for more than a day outside of a Sioux Falls Best Buy store.

Thirty-one-year Ben Bouza and 37-year-old David Havermann lined up outside the store about 1 p.m. Wednesday. The two — who are second and third in line of about 10 people — didn't know each other but quickly became friends as they passed the time watching movies on Bouza's laptop and playing cards.

Both men say they only got a few hours of sleep Wednesday night. Bouza slept in his truck, while Havermann spent the night in an ice tent with portable heater.

SIOUX FALLS (AP) — South Dakota officials are seeking an end to a federal requirement that underperforming schools offer free, thirdparty tutoring to students from low-income families. Education Secretary Melody Schopp says request to waive many

provisions of the No Child Left Behind law will include the elimination of mandatory spending on supplemental education services. Schools that receive Title I money must spend 20 percent of it on

tutoring. The programs are popular with parents, but the Argus Leader reports they've shown little difference in children's math and reading

The latest evaluation report on the program services shows children who received tutoring made slight year-over-year improvement on standardized tests in reading but lost ground in math.

USDA: \$189M Invested In Neb. In FY2011

LINCOLN, Neb. (AP) — The U.S. Department of Agriculture says Nebraska received more than \$189 million in rural support during the federal fiscal year that ended in September.

The agency's annual report says the money went to housing, business and community development, energy projects and telecommunications. The money was part of the USDA's Rural Development

The program's home ownership initiatives had a record year of funding, with \$115 million that helped more than 1,200 households. Rural development money helped provide affordable rent to more than 2,500 tenants.

Nebraska State Director Maxine Moul says the program is intended to strengthen rural communities throughout the state.
