Yankton Tabs Nelson As New City Manager

Canton City Manager Will Be First Woman To Hold Position

The City of Yankton announced Thursday afternoon that the current city manager of Canton will assume that position here beginning Jan. 2. Amy Nelson, 35, has been the city manager

of the Lincoln County community of approximately 3,000 residents for the past four years.

The announcement of Yankton's first female city manager came during a news conference at City Hall with many city department heads in attendance.

"Yankton is on the cusp of great things, and I can't wait to roll up my sleeves and get involved in them," Nelson stated. "I'd like to thank the City of Yankton for selecting me, and I'd also like to let the public know that I will work hard to achieve the goals of the community."

Nelson is a native of Ortonville, Minn., has a

bachelor's degree from Minnesota State University-Moorhead and a master's degree from Minnesota State University-Mankato. She has worked in a couple states in positions that include downtown development director and senior community planner prior to becoming the city manager of Canton. Nelson has also been employed by the Brick Industry Association.

Mayor Nancy Wenande said the commission wasn't worried about the fact that Yankton would only be Nelson's second city manager

"Her just having served as the city manager for four years really was minimized by the fact she had so much other experience to bring to the table," she said. "Through all facets of the interview process, the (City Commission) was impressed with Amy's high level of professionalism. She was able to showcase her skill set

S.D. Dems, Daugaard Argue Over 'Pay To Play'

The South Dakota Democratic Party and the Gov. Dennis Daugaard administration are at odds over whether there is a "pay to play" culture in Pierre that benefits the dominant Republican Party.

Rep. Bernie Hunhoff (D-18), the House Minority Leader, believes the numbers speak for themselves.

"Even though it's impossible to determine how much money the state is giving away in the name of economic development, it's now clear corporate welfare recipients are giving hundreds of thousands right back to Republican leaders in Pierre," Hun-

He and the South Dakota Democratic Party reviewed grants awarded through the Revolving Economic Development and Initiative (REDI) fund between 2007 and 2011, as well as the Futures Fund from 2000-2010. Research into other sources of economic development funds was prevented, according to Hunhoff, by a lack of transparency and open records.

The research identified \$329,968 in political contributions to Republicans from corporate directors who received more than \$29 million in state grants. Hunhoff is calling for legislative reforms that would prohibit political contributions that appear to be payback for economic development grants or the awarding of a state government contract.

He first made the accusation during a news conference ear-

Hunhoff said he doesn't blame the corporate officers of companies for getting as much assistance as they can.

"But the politicians should be watching out for the best interests of the state's taxpayers," Hunhoff stated. "The corporate recruiters and politicians are salesmen, and salesmen will give away whatever it takes to make a deal — even when the deal doesn't make good sense for the folks paying the bill."

Survey Suggests Economic Slump Looming In Midwest

OMAHA, Neb. (AP) — Another economic slump may be developing in the Midwest and Plains states, according to a survey of business leaders released Thursday.

The Mid-America Business Conditions index is based on monthly surveys of business leaders and supply managers in nine states. It includes a collection of indexes ranging from zero to 100. Survey organizers say any score above 50 suggests growth while a score below 50 suggests decline for that

The overall index dropped to 46.5 last month from 50.4 in September, the report said. It was 57.2 in June but fell

below 50 in the following months. "Surveys over the past several months point to slightly negative growth for the next three to six months," said Creighton University economist Ernie Goss, who oversees the survey. "However, as in (the) past months, two states with significant dependence on energy, North Dakota and Oklahoma, will continue to expand at a positive pace while the rest of the region pulls back.

The survey covers Arkansas, Iowa, Kansas, Minnesota, Missouri, Nebraska, North Dakota, Oklahoma and South Dakota.

While business leaders' responses indicated an economic slump was ahead, they expressed more confidence in October than the month before. Last month's business confidence index jumped to $58.0\ from\ September's$ very weak 44.7.

"Despite less favorable business conditions for their own firms, supply managers are more positive about the

overall economy in the months ahead," Goss said. He said drops in the national unemployment rate and upturns in the U.S. housing market were boosting the economic outlook of those who responded to the survey.

In the October survey, the supply managers were asked to gauge the likelihood of a 2013 recession.

The survey report said that 23.4percent who responded said they

Yankton Police Seek Suspect In Robbery

The Yankton Police Department is seeking a suspect in the Wednesday night robbery of a local business.

According to a media release from police, a man with a firearm entered the Prairie Pumper Convenience Store at 909 Broadway Avenue at approximately 11:41 p.m. Wednesday and demanded cash from the clerk.

The suspect is described as approximately 6 feet tall with a heavier build. He was wearing dark-colored pants and a dark-colored, hooded sweatshirt.

The man fled the scene with an undisclosed amount of cash. No one was injured during the incident.

It's at least the second time the Prairie Pumper has been robbed in recent years.

At around 11 p.m. Sept. 5, 2011, a suspect entered the store, confronted an employee and took an undisclosed amount of money before fleeing.

No arrest was made in connection with

that incident, and police said Thursday they have no reason to believe they are
