## Man Sentenced For String Of Area Thefts BY NATHAN JOHNSON burglary, third-degree intentional damage During the hearing Friday, Thompson

A 21-year-old Yankton man received a suspended imposition of sentence and five years of probation Friday after pleading guilty to dozens of thefts in the area.

Matthew Eugene Thompson appeared at the Yankton County Courthouse and Safety Center Friday afternoon before Circuit Judge Glen Eng.

Thompson was arrested by the Yankton County Sheriff's Office in September and was charged with grand theft, third-degree

to property and receiving stolen property. He admitted to approximately 30 incidents of camper and boat battery thefts, as well as gas thefts in Gayville, Irene, Yankton and the Lewis and Clark Lake area. Authorities were able to track Thompson down after speaking with battery dealers.

Several of the charges were dismissed, and Thompson pleaded guilty Oct. 29 to grand theft, a Class 4 felony punishable by up to 10 years imprisonment in the state penitentiary. In addition, a \$20,000 fine may be imposed.

During the hearing Friday, Thompson told the court, "I just feel really bad about what I did.'

Defense attorney Luci Youngberg said that, when she first met her client, he was immature and in denial about what he had done. However, since being in jail, "he has grown up quite a bit," she added.

According to Youngberg, Thompson's father died when he was young and his

mother was rarely around. She also pointed out that Thompson was

## **USD Football Players Indicted On Tax Fraud**

SIOUX FALLS (AP) — Nine people in South Dakota and Florida, including four former University of South Dakota football players and one current team member, have been indicted by a federal grand jury for tax fraud conspiracy and identity theft, prosecutors said Friday.

The defendants are accused of stealing people's identities and filing bogus income tax returns showing about \$1.1 million in refunds due, said Brendan Johnson, the U.S. attorney for South Dakota. The Internal Revenue Service paid fraudulent claims of about \$500,000 before the scheme was uncovered, Johnson

Current USD football player Christopher Lundy is among the defendants. The 20-year-old sophomore defensive back from Tampa, Fla., was arrested Thursday in South Dakota along with Terry Liggins, a former track athlete at USD.

Five others were arrested Thursday in the Tampa area, including three former USD football players. Two other suspects had yet to be arrested Friday, according to Johnson.

Lundy and Liggins appeared before a federal magistrate on Thursday, pleaded not guilty and were released pending trial.

The five arrested in Florida appeared before a magistrate judge there Thursday. They were released and ordered to appear in federal court in South Dakota on Dec. 10, Johnson said.

USD spokeswoman Tena Harald-son told The Associated Press no formal disciplinary action has been taken against Lundy but that he will not play Saturday when the team takes on in-state rival South Dakota State "due to the circumstances."

'The university feels it's best for



that were on the list. One of the five arrested in Florida, former USD football player Alphonso Valdez, is accused by the IRS of being the leader of the fraud scheme, according to the Tampa Tribune. Assistant U.S. Attorney Sara Sweeney told U.S. Magistrate Anthony Porcelli that Valdez recruited students at USD and people he knew in Tampa to gather names, addresses and other identifying information, and used that information to file the fraudulent tax

Sweeney told Porcelli the scam came to light when Valdez used pre-loaded debit cards to withdraw \$900 in cash from an ATM in South Dakota. Valdez tried to hide his identity by wearing sunglasses and a stocking cap, she said. Authorities say people committing tax refund fraud frequently direct that the fraudulent refunds be deposited on

debit cards. Valdez's lawyer said in court that Valdez now plans to attend the University of Tennessee, where he has been accepted on a football scholar-

ship.
The conspiracy charge carries a maximum sentence upon conviction of 10 years in prison and a \$250,000 fine. The identity theft charge has a maximum punishment of two years in prison.



### **Gavins Point Dam Repairs** Slated To Begin Next Week

While the floodwaters of 2011 receded long ago, work continues at Gavins Point Dam to recover from the damage left behind, with the most extensive repairs about to

Officials at the dam are set to start a two-year project next week to repair flood-related damage to the spillway area, according to Gavins Point operations project manager Dave Becker.

We have quite a bit of flood repair work that's been going on, but now the lion's share of it is about to get going," he said.

Becker said the U.S. Army Corps of Engineers is expected to close the dam's spillway gates around Thanksgiving, which will allow work to begin to fill two large voids under the concrete and to remove a "tremendous amount" of debris from the spillway. The spillway gates will also be repainted and resealed, and new lifting cables and new brakes will be installed.

"It's really just starting now, and it's really going to be a big, two-year project," Becker said.
