Yankton County Hwy Superintendent Honored

The South Dakota Association of County Highway Superintendents (SDACHS) honored retiring Yankton County Highway Superintendent Alan Sorensen at a Nov. 7 luncheon at JoDean's in Yankton.

SDACHS, a subsidiary of the South Dakota Association of County Commissioners (SDACC), is governed by South Dakota county highway superintendents who are appointed annually to the SDACHS Board of Directors by their peers. Creighton Scores High Marks On State Report

CREIGHTON, Neb. — Creighton students and school officials are celebrating more than the Thanksgiving holiday.

Creighton Community Public Schools learned Tuesday they scored exceptionally well on the Nebraska State of the Schools Report, according to Superintendent Jeff Jensen.

The rankings, known as the Nebraska Performance Accountability System (NePAS), were officially released.

The Creighton Community Schools ranked number one overall in both reading and math. The Creighton Elementary ranked first in math, second in reading and fourth in science (state writing was not ranked in the elementary in 2012).

Out of 15 major sub-groups, Creighton ranked as the top school in three categories and as runner-up in one sub-group. The district scored among the top 10 districts in nine of the 15 categories.

Jensen said a school celebration was planned for today (Wednesday), just before the start of the Thanksgiving break.

"Our students did an exceptional job, and their accomplishments on this test are remarkable," he said. "Our overall performance on this test is unrivaled and supports what our district is accomplishing through collaborative effort."

Jensen credited a total team effort for the school's success.

"This accomplishment can be contributed to hard-working students, their excellent teachers, their nurturing families and their supportive community," he said.

After several years of the Nebraska State Accountability (NeSA) test, schools are now ranked on how they perform on the reading, math, science and writing tests, Jensen said.

Rankings are created in each of the curricular areas. Schools are compared to other high schools, middle grades and elementary grades. They also receive an overall district ranking.

Students are tested each spring. The information is then tabulated, and the 249 school districts across Nebraska are ranked based on

performance.

The performance on the 2012 NeSA tests speaks volumes for the Creighton Community Public Schools and their outstanding academic achievement, Jensen said. The school district has consistently scored well above state and national averages on assessments, including the State NeSA tests and the ACT college entrance exam, he said. The Creighton district's ACT averages have been exceptional, he said, and a perfect score was achieved in 2011.

"This success can be accredited to the high expectations the district has for their students and staff," the superintendent said. "In addition, high scores can be attributed to a strong early childhood program that supports a strong, rigorous curriculum. The success of the early childhood programs is evident in the elementary grade NeSA scores."

The Creighton district performed a tremendous job in 2012, but there are areas to improve on, Jensen said.

"We are going to sit back and enjoy our success on this test, but we will continue to move forward by continuing to support strong expectations for our students and staff," Jensen said.

"We have areas that we can improve on, and we cannot be complacent. It is imperative that we provide our students with the very best education opportunities."
