Neb. Schedules Health Care Law Hearings

LINCOLN, Neb. (AP) — Nebraska lawmakers have scheduled a joint hearing to examine how the federal health care law will affect the state budget.

The Health and Human Services Committee and the Appropriations Committee will meet Tuesday to examine the impact the health care law might have on the budget in upcoming years.

The National Conference of State Legislatures will brief lawmakers in the morning about the health care law and Medicaid, as will the director of the state's Medicaid Division.

Lawmakers will also study the new costs and long-term state savings that are possible under the health care law.

Hunters Invited To Register For Special Hunts

SIOUX FALLS (AP) — The South Dakota Department of Game, Fish and Parks is encouraging hunters to register for special winter depredation hunts of nuisance species.

Applicants are placed in a pool of hunters who can be called if landowners in their area are having problems with wild game getting into livestock feed.

The Argus Leader reports that registration for potential seasons for deer, antelope and turkey opens Saturday. If a depredation hunt is authorized, participants are selected by random drawing.

Keith Fisk with the agency's wildlife damage program says hunters would need to be able to be at the hunt location within a day or two.

Iowa Mom Pleads Guilty In Drunk Toddler Case

IOWA CITY, Iowa (AP) — An Iowa City mother arrested after her 23-month-old son was found to be legally drunk has pleaded guilty to felony child endangerment and neglect or abandonment

Natasha Kriener was charged in February after doctors found the toddler had a blood-alcohol level of .09 percent, above the state's legal limit of .08 percent. Police said the toddler's father had taken him to the hospital because he was crying and had poor bal-

Cedar Rapids television station KCRG-TV reports that the 27year-old Kriener pleaded guilty Monday. She had been set to go to trial in September, but failed to appear for a hearing and disappeared for nearly three months. She was arrested Nov. 1 on a war-

She faces up to 15 years in prison if convicted of the charges.

Grief Counselor On Hand For N.D. Community

NEW TOWN, N.D. (AP) — A grief counselor who provided support to a Minnesota reservation following a deadly shooting spree and victims of the Oklahoma City bombing is in New Town to help the community deal with the death of four residents.

Jacqueline Gray has been on hand since Wednesday, offering grief support following the deaths of Martha Johnson, 64, and three of her grandchildren — Benjamin Schuster, 13, Julia Schuster, 10, and Luke Schuster, 6 – on the Fort Berthold Indian Reservation, the Minot Daily News reported in a story published Saturday.

Police described Kalcie Eagle, 21, who

killed himself the same day as the shootings, as a person of interest. Eagle lived a block from Martha Johnson.

Gray is associate director of indigenous programs at the Center for Rural Health and the Department of Pathology at the University of North Dakota School of Medicine and Health Sciences. She previously offered grief counseling at Minnesota's Red Lake Reservation after 10 people were killed in 2005, and after the 1995 Oklahoma City bombing, which killed 168 people.

"There are things that are the same and things that are different," Gray said of the

concerns people have in New Town compared with the concerns at previous

tragedies.
"I think parents are concerned about their kids dealing with a classmate who has died, and also worried about dangers that might remain," she said.

The FBI, which has is handling the investigation because it happened on a reservation, has said community members are no longer

The Fort Berthold Reservation is home to the Mandan, Hidatsa and Arikara, who are known as the Three Affiliated Tribes.

SDSU Student Tracking Elusive Bobcats

HOOVER — Northern Butte County is barren, sparsely populated and good bobcat country.

On any given day, Eric Ness can be found checking his cage traps to see if any of the elusive cats are inside.

Ness, a graduate student at South Dakota State University, began a two-year study of bobcats in the prairies of western South Dakota for the state Game, Fish & Parks Department.

"They are curious on harvest rate and the population," Ness

Ness began trapping in late summer around Hoover.

Using cage traps he hoped to capture a large number of bobcats, but things started slow for the novice trapper. He enlisted the guidance of state trappers who said he was in good bobcat country and his sets looked good.

"But the bobcats here are so rare," Ness said. "They don't travel much, so you really have to find where they hang out. It's been so dry that I haven't been able to find much sign or tracks or scat.

There is a short bobcat trap-

ping and hunting season that begins in mid-December and ends in February. During the 2011-2012 season 713 bobcats were killed statewide with the largest numbers coming from: 41 in Butte County; 51 in Meade County; and 85 in Harding County, according to the South Dakota Game, Fish and Parks. The vast majority of the bobcats were trapped.

After a month of running his trap line with no bobcats in his traps, he took to the air to locate better habitat for the bobcats.

He found a large stock pond and ravines with good cover for grouse and rabbits, prey species for bobcats.

"What I've been trying to find is areas they would like to be in,"

He placed his 23 traps throughout the area, often times placing two traps at one location in hopes of trapping a female and her young.

Finally he saw two eyes staring back at him from inside a

"I caught him by a little cedar tree," Ness said. "He was a 23pound male, a very good looking cat, with no fleas, no ticks and no parasites."

Ness and another GF&P biologist conducted fieldwork on the bobcat and fitted him with a radio collar.

But unfortunately days later, the signal from the bobcat's collar disappeared.

"It could have malfunctioned, the cat could have been hiding in culvert or, since it was a young male, it could have traveled out of the area," Ness said.

He has expanded his trap line ever since, and what once took him a couple hours to check, now takes him most of the day.

Next week he will begin a new trap line near Union Center in Meade County.

Ness said collaring bobcats will allow him to see what type of terrain they prefer, to see movement patterns and even will indicate if one of the animals has died so biologists can determine how they died. Additionally the bobcats will be part of a mark and recapture study. Biologists are able to estimate the population when they look at the number of marked or collared animals killed versus the nonmarked animals. Ness said his study is slated to last two years and with functioning collars, data could be collected for another few years after that.

Husband, Wife Arrested After Northeast Neb. Shooting

NORFOLK, Neb. (AP) — A Madison, Neb., couple have been arrested following a shooting outside a Norfolk bar and a high speed chase.

Sioux City, Iowa television station KTIV reports that 28year old Jordan Beehn and his 25-year-old wife, Kelly Beehn, were arrested early Saturday morning following a high-speed chase on Highway 24 in Stanton County. Sheriff's deputies arrested Jordan Beehn on suspicion of driving drunk, then learned that he was a suspect in a Norfolk nightclub shooting.

Norfolk police say Beehn and his wife were leaving the Norfolk bar early Saturday when Kelly Beehn got into a fight with another woman. Police say when another man tried to break up the fight, Jordan Beehn shot the man in the

The shooting victim was flown to Mercy Medical Center in Sioux City.


