The City Council voted 4-3 for a resolution to lobby the Nebraska Legislature next year to pass a bill that would allow the change. The measure would pertain only to those living in the 3-mile zone or in separately taxed sanitary and improvement districts, which are formed to provide new housing developments basic services such as power, sewer and water services and roads. The districts are most commonly known as SIDs, and are found just outside city limits or in undeveloped areas in the city.

after hearing complaints for years from people in neighborhoods just outside the city who have little to no say in their planning and development.

While SIDs have elected boards, the decisions of those boards can be overridden by the city planning commission, Thompson said. As an example, he pointed to the city's

approval this week of a 272unit apartment complex in a southwest Omaha neighborhood, Grove Ridge, outside city limits. The approval came over the protests of residents in the neighborhood and the neighborhood's SID board, who said it was too large for the neighborhood and would cause traffic problems.

"How can the city have that much power over an area outside the city?" Thompson asked. "The question is: Is

that fair?"

But Gray said Thursday that allowing those outside the city who don't pay taxes for city bonds, roads and other infrastructure to vote in city elections would violate the U.S. Constitution's equal protection clause, as well as the Voting Rights Act.

'It would dilute the minority vote inside the city, and that is unconstitutional," he said. "If they want to vote, they need to move to the city and pay city taxes. In other words, you need to pay to play. It is that simple."

Council members Garry Gernandt, Aimee Melton and Rich Pahls joined Thompson in voting for the change. Council members Chris Jerram and Pete Festersen joined Gray in voting against it.

## South Dakota To Probe Reports Of Poker Cheating In Deadwood

DEADWOOD (AP) — South Dakota's gambling commission is looking into reports of cheating at poker tables in the western gam-

bling town of Deadwood. The state Commission on Gaming has received numerous informal complaints in the past couple of years of players working together in poker games to obtain the chips of opponents, Commissioner Dennis Duncan said.

"There's a perception out there in the public that the games aren't on a level playing field," he said. "Sometimes perception becomes reality in certain people's minds, and I think that's the point where we're at. If there are 10 people talking about it, that's 10 people too many.

"The commission is here to ensure the integrity of those games for the public," he said

The commission has approved hiring a consultant to look into the validity of the collusion claims and to provide recommendations to casinos on how to identify cheating at poker tables, the Rapid City Journal reported.

Commission Executive Secretary Larry Eliason in a Nov. 5 letter to several major casino owners said the commission was concerned that casino owners and managers "may not take this matter as seriously as does the commission.

#### **Court Says No To New Malpractice Trial**

PIERRE (AP) — The South Dakota Supreme Court has ruled that a woman who sued Sanford Medical Center for malpractice for a 2007 surgical procedure that was aborted should not be granted another trial.

Lisa Lewis sued Sanford after an anesthetist mistakenly attached a stomach tube to an oxygen supply rather than a suction device during prep for laparoscopic gastric band surgery. Lewis claimed that the flow of oxygen into her stomach caused cardiac problems, which led to the need for a pacemaker.

Sanford admitted negligence but denied that its negligence caused damage.

A jury awarded zero damages and Lewis appealed, and the circuit court granted her a new trial.

Sanford appealed that decision to the Supreme Court, and the justices on Thursday reversed the circuit court's order for a new trial.

#### **Gambling Commission Punishes Casino**

DEADWOOD (AP) — South Dakota's Commission on Gaming has punished a Deadwood casino for failing to provide acceptable revenue reports over several years.

The *Rapid City Journal* reports that the group fined the Four Aces Casino \$25,000 and suspended the business's gambling license for 15 days, effective Dec. 2. Executive Secretary Larry Eliason says it's the largest penalty he can remember in his nearly two decades with the commission. The casino plans to appeal.

The commission says the casino has repeatedly failed to provide accurate, complete and legible revenue reports, dating to 2008.

Casino Chief Financial Officer Steve Comer says the reporting errors were due to changing state reporting requirements and problems with the casino's antiquated software program. He says Four Aces hired a consultant to address the problem.

#### **Police: Mines Faculty Took His Own Life**

RAPID CITY (AP) — Rapid City police say a South Dakota School of Mines & Technology faculty member apparently took his own life on campus. The school canceled classes in the Electrical Engineer-

ing/Physics building late Thursday morning after the man's body was found. The university sent out alerts to students and staff

telling them to avoid that part of campus. School of Mines canceled classes for the day in the

building and made counselors available. Late Thursday afternoon police updated a news release indicating that it appears the man died from a self-inflicted gunshot wound.

Police did not release his name because his family has not been notified.

## **Baskets Headed To Troubled Ranchers**

AMIDON, N.D. (AP) — Some ranchers and others in southwestern North Dakota are sending a bit of holiday cheer to their counterparts in northwestern South Dakota who are recovering from a devastating early October blizzard.

Volunteer Linda Narum, of Amidon, tells KXMB-TV that donations of everything from turkeys to homemade pies to money have been coming in from around Slope County. She says she's overwhelmed by the support. More than 200 people have contributed items or volunteer time for the Thanksgiving baskets.

Children began putting the baskets together on Wednesday and were continuing Thursday. Volunteers plan to deliver the baskets on Friday.

The blizzard that hit with surprising intensity on Oct. 4 dumped up to 4 feet of snow in western South Dakota, killing more than 15,000 cattle, sheep, horses and bison.
