## **Emergency Operation Center Tested**

Representatives of several local emergency service departments recently took part in a two-day class and training exercise to further develop the local Emergency Operation Center (EOC). The EOC is the centralized support system for medium to large scale emergency inci-

The training included participants from the Yankton County Office of Emergency Management, Yankton County Emergency Medical Services, Yankton Police Department, Yankton Fire Department and emergency management departments from Bon Homme and Hanson

We had our EOC up and running during the Missouri River Flood in 2011 and that gave us a good understanding of our strengths and weaknesses," says Paul Scherschligt, Director of the Yankton County Office of Emergency Management. "Training and exercising our operation like this helps us to build on what we already have in place and to improve the operation to better serve and protect the community in the future, regardless of the type of threat to life, property or security."

The exercise scenario included responding to various potential threats to the local community, including a mass casualty incident, terrorism, hazardous material exposure, bomb threat, vehicle chase, hostage situation and water search and rescue and recovery.

Scherschligt says the recent training both challenged and strengthened the local response effort.
