# **Use Caution During Controlled Burns**

If a controlled burn is in your plans, Yankton Deputy Fire Chief Larry Nickles asks that you familiarize yourself with the

rules of conducting it beforehand. One day last week, he said he observed five controlled burn violations in

the Lewis and Clark Lake area alone.

You need to call in your controlled burns," Nickles said. "Only two of the fires that day had been called in.'

Residents should call the Yankton County dispatch center at 668-5210 prior to doing a controlled burn and inform officials when and what they plan to burn.

Burning must occur between sunrise and sunset and is limited to things like vegetation, tree piles and rubbish. County law prohibits items such as rubber-type products, petroleum products, asphalt shingles and most chemicals from being burned.

"Be mindful where the smoke is going," Nickles added. "I've had a couple instances where the smoke was going into the neighbors' residences because the wind had laid the smoke down.'

In one recent case, Nickles asked that a fire be extinguished for that reason. He also requested that motorists do a little investigation of what is burning beThat can prevent the unneeded dispatch of fire department resources. Each year, Nickles makes an effort to

fore reporting that a fire is out of control.

educate residents about Ordinance 17, which lays out the rules for controlled burns in the county.

"We'd prefer to educate people to do it right. Most of the time, we'll issue a warning," he said. "But if violations become habitual, we'll give out a ticket.'

# Winter Could Be Cooler For South Dakota

BROOKINGS — The temperature and precipitation outlook for December in South Dakota remains somewhat mixed in the National Oceanic and Atmospheric Administration latest seasonal

climate outlook released this week. For South Dakota, this means equal chances of below average or above average temperature for the next month. The same probabilities hold for precipitation as well, said Laura Edwards, SDSU Extension Climate Field Specialist.

Edwards added that just to our

north, there is a higher likelihood of cooler than average temperatures in December. South Dakota remains between the likely cooler than average to the north and warmer than average region in the southern US.

"The winter outlook, which covers December through February, leans toward colder than average temperatures - especially in the northern part of the state," said Edwards, following the Nov. 21, 2013 release of the national outlook. The jet stream will likely continue to break repeated cold outbreaks similar to what the area has seen the last several weeks.

For precipitation, Edwards said part of Wyoming and Montana are more likely to receive above average precipitation in December. She added that looking ahead to the winter season through February 2014, there remains some uncertainty for the precipitation patterns that will prevail. But a similar
