Hudson To Be Evaluated By State

A status hearing Friday for a Yankton man accused in a March death has led to the state calling for its own psychiatric evaluation. Joshua Hudson, who is accused of murdering his uncle, Todd Hud-

Joshua Hudson, who is accused of murdering his uncle, fold Hud-son, in March, did not appear in court for the hearing. Hudson's court-appointed attorney, Dan Fox, said the evaluation report, conducted by Dr. Melissa Spanggaard of Sioux Falls concluded that Hudson is suffering from schizophrenia and would've been de-fined as legally insane at the time of the killing. Deputy State's attorney Erich Johnke asked that a new forensic evaluation be conducted this time by doctors at the Human Services

evaluation be conducted, this time by doctors at the Human Services Center (HSC). Johnke said the earliest these could be done is mid-late February.

First Circuit Judge Glen Eng ordered the evaluation be conducted by staff at HSC as soon as possible and that Spanggaard's reports be sealed.

On March 7, authorities were called to check on the status of Todd Hudson. Joshua Hudson showed up at the residence of Todd's ex-wife and was quoted as saying "I axed my uncle." Hudson was appre-hended following a high-speed chase later that day. The next status hearing is set for March 16, 2015.

This past year a mother and four children were traveling through Yankton. Their car broke down and needed to be repaired.

The woman had the cash to fix her vehicle but no other money. They found themselves stranded in Yankton for a couple of days. Part of the monies collected during the 2013 Salvation Army Red Kettle campaign helped this family in providing them with a motel room, food and gas.

This was just one example of the distribution of funds by the Salvation Army. Of the \$7,500 raised last year, 90 percent stayed in Yankton. The other 10 percent went to the district Salvation Army.
