and board members about offering courses in the Cedar County community.

You said, 'We want more of a presence for NECC," Chipps told the Hartington audience. "We brought (your request) to our senior staff and asked, 'How do we get this done from this point on?' We are here for all the right reasons.'

NECC already operates branches in West Point, South Sioux City and O'Neill, Chipps said. However, the college didn't have a presence in Cedar and Knox counties

"That leaves a big gap. But (coming to Hartington) isn't just a matter of completing a map," he said. "We are completing what community colleges are charged to do. We are bringing education to the masses without them having to travel long distances to get it done.'

And now, post-secondary education is being offered in another part of northeast Nebraska, Chipps said.

'You in Hartington have worked hard and pushed hard to make it happen," he said.

The Hartington venture became reality earlier this year. NECC regional coordinator Russ Flamig works out of an office in the Hartington city hall. Flamig is no stranger to the region as he retired last spring after a 32-year career in education, most recently as a Hartington Public School principal.

The NECC branch offered dual credit courses this fall for the Hartington Public and

hand with Hartington's emphasis on entrepreneurship and rural revitalization, Chipps said. He pointed to the community's string of economic successes such as a new motel and a 19unit housing development.

"The sign says you're a community of 1,640 residents, but it seems much bigger than that,' he said. "Thank you for being a progressive community. You're different in a very positive way.

NECC is ready to build on the partnership, Chipps said.

We believe in Hartington. We are here to celebrate with you," he said. "Russ (Flamig) is a go-getter. He will help move the needle in the right direction

Hartington officials returned the praise, including an excitement about Flamig's familiarity with the community and surrounding region.

Attracting NECC has been in the works for some time, said Chris Miller, president of the Hartington economic development committee.

We wanted to bring a postsecondary influence into our area. It's helpful that we have Steve (Anderson) as a board member. We're very fortunate that this day arrived.'

NECC's arrival signals just the beginning, according to Karma Schulte, president of the Hartington Chamber of Commerce.

She sees potential for setting up a building for NECC courses and the use of Hartington's telecommunications for delivery of courses.

"We have the opportunity to grow as a community by offering post-secondary education." she said. "We are offering programs we couldn't do before."

Becker sees the NECC campus exerting an impact throughout the area.

We are looking at serving far beyond Hartington," she said. "We are looking to serve Cedar and Knox counties. This is a huge regional asset.'
