# Hong Kong Protesters Try To Storm Legislature

HONG KONG (AP) — Hong Kong police arrested four men early Wednesday after a small group of protesters tried to force their way into the city's legislature in overnight clashes.

The arrests came after authorities cleared some barricades a day earlier from a small section of a site occupied by pro-democracy activists for nearly two months.

Police used pepper spray against the umbrella-wielding protesters, who they said repeatedly charged their cordon and injured three officers.

The protesters used metal barricades and concrete slabs to smash glass doors at the entrance to the legislature.

At one point, pro-democracy lawmaker Fernando

Chiu tried to intervene but was pulled aside by some protesters so that others could continue ramming the

Chiu told reporters that he saw one person enter the building.

He and other lawmakers from the so-called "pan-democrat" camp condemned the violence, saying it undermined the non-violent protest movement.

The student-led democracy protesters reject restrictions laid down by Beijing on inaugural 2017 elections for the southern Chinese financial hub's top leader.

The clashes and the court-ordered barricade clearance hours earlier underscore the protest movement's turn to a riskier phase as student leaders run out of options.

# **Climate**

The growing season has dramatically lengthened throughout U.S. history, Moore

"With the old varieties of corn, the Native Americans were planting 70- to 80-day corn," he said. "Today, it's common to have 120-day

Moore credited three major factors. "We have longer growing seasons, warmer winters and nights, and more frequent precipitation," he said.

The longer growing seasons mean more heat and sunlight for corn, affecting the yields per acre, he said. However, the longer seasons also mean the corn crops face greater chances of major storm events, he added.

The United States has seen dramatic change in its agriculture practices, Moore said.

"Traditionally, Native Americans grew the three sisters - corn, beans and squash - together as complimentary crops," he said. "The corn was important throughout their culture. It played a prominent role symbolically in their culture and religion.

Today, American farmers rotate corn and soybeans, sometimes with wheat in the rotation, he said. That wasn't always the case, as soybeans became popular in the Midwest only in the 1960s, he noted.

Through the years, farmers have also used a minimum or

no-till strategy, he added. Now, climate change is impacting agriculture, Todey said. He pointed to overall arınıng, ranging ironi warinei winters to warmer overnight temperatures

The longer growing season has typically brought changes in corn variety and more productivity, Todey said.

However, climate change has also brought different weather patterns, he added. The Midwest has seen an

overall increase in precipita-

tion along with changes in

temperatures, he said. The precipitation is also occurring during different times of the year than we have seen (in previous years)." he said. "Sometimes, it doesn't line up well. There is more precipitation in the mid-summer. which isn't a bad thing. It's the time of year when crops are most actively growing. But we are also seeing a shift to more

spring and fall precipitation." The wetter spring and fall seasons can greatly affect both planting and harvesting,

Todev said. "In the spring, farmers are

trying to get into the field and get planted. If you have a wetter field at that time, you aren't able to get into the field, or you have more compaction of that field." he said. "In the fall, you may have the inability to get in the field and get your harvest out, which carries over into the spring.

Intense precipitation events can cause more erosion as well as flooding, he added.

The Midwest has seen years ranging from widespread drought with large-scale crop and livestock losses, to ideal conditions with bountiful harvests, he noted.

The USDA grant has been used to study greenhouse gas emissions and the impact of crop management practices, Moore said. In addition, the research looks at the resulting carbon, nitrogen and water footprints.

The researchers have surveyed Upper Midwest farmers. The survey measured the farmers' attitudes on whether the government and/or individual farmer should do more to reduce greenhouse gas

emissions. In addition, farmers were asked if they believed sufficient evidence existed that climate change was occurring, Moore said. Farmers were also asked whether they thought climate change could be manmade, caused by natural events or a combination of

The survey revealed 31

percent of the respondents found insufficient evidence that climate change was occurring, Moore said. A chart showed a difference in attitudes from one part of the Midwest to the other end.

"It may have been based on their beliefs and their own experiences and local situation,3 he noted.

The Midwest has pulled out of a severe drought in recent years. However, other parts of the nation aren't so fortunate, and the Midwest stands to feel the impact.

We are seeing abundant rainfall compared to California." Moore said. "But we'll find it's a precious commodity, and there will be additional water demand by 2030.
