Visa Ban For Ebola Countries Wanted

SIOUX FALLS (AP) - U.S. Sen. John Thune has joined other Republicans in calling for a temporary visa ban on those attempting to travel to the U.S. from Ebola-affected countries in West Africa.

Thune says he has "questions" about the country's ability to manage "the threat that Ebola poses" to the transportation sector, including airports and ports.

The proposed legislation would suspend new visas and revoke current visas for individuals who are permanent residents or nationals of a country the CDC has designated as a country for "widespread transmission of Ebola." Some exemptions would apply.

The White House has pushed back against overly restrictive measures, including proposals for travel bans.

The World Health Organization has said the Ebola epidemic in West Africa has sickened more than 15,100 people and caused more than 5,400 deaths.

Rounds Announces Committee Choices

SIOUX FALLS (AP) — Republican Senator-elect Mike Rounds is expressing concerns over President Barack Obama's expected administrative actions on immigration.

Rounds on Thursday told reporters that Obama's decision to act unilaterally will hurt his already damaged relationship with Congress. But, Rounds warned, he doesn't expect lawmakers to use spending-bill tactics to shut down the government over Obama's decision.

Defying the GOP and bypassing Congress, Obama prepared to use his executive authority Thursday night to spare nearly 5 million people in the U.S. illegally from deportation.

In a wide-ranging discussion with reporters, Rounds also said he has put in requests to serve on three U.S. Senate committees. He selected the armed services; banking, housing and urban affairs; and environment and public works committees.

No Direction From Meeting On Ditch-Mowing Rules For Pheasants

PIERRE — Four citizens testified Thursday at a special meeting regarding the effects on South Dakota's pheasant population from mowing state highway ditches.

The state Transportation Commission held the meeting in response to a recommendation from the governor's work group on pheasant habitat

Nothing concrete came from the comments

Several landowners said the rules should be changed to allow earlier mowing. A hunter said state government should set an example for others by further restricting the mowing.

State rules set by the commission allow mowing year-round in the rights of way along two-lane state highways in most of the counties west of the Missouri River.

The rules prohibit mowing before June 15 in the western counties of Gregory, Lyman and Tripp.

The rules also prohibit mowing before July 10 in all counties east of the Missouri River.

Tony Leif, director for the state Wildlife Division, presented a research paper he wrote 10 years ago on pheasant nesting.

Leif outlined five options. One would limit mowing to once per five years and it couldn't start until Aug. 1 that year.

Another of Leif's options suggested mowing one side of the highway per year, again with an Aug. 1 start date.

His third option was changing the mowing date statewide to Aug. 1 The fourth option was keeping the

July 10 starting date. The fifth option was removing all restrictions on mowing that are related to pheasant reproduction.

Leif said the peak of the incubation period for nesting hen pheasants is about June 15. He said hens wait until they have a full clutch — typically 11 to 12 eggs and then begin sitting on them to incubate them. The incubation period is 23 days, followed by one to two weeks before the chicks can fly.

Bill Smith from the state Agriculture Department testified but didn't take a specific position regarding changes in the rules.

"It's always a matter of balance," Smith said.

Bob Benson of Winner asked Smith for information on the financial importance of roadside hay to agriculture producers. Benson is a former state legislator and the current chairman of the Transportation Commission.

Benson lost a lawsuit before the South Dakota Supreme Court that sought to

restrict pheasant hunting from roadside ditches.

"It's got to be a big number," Benson said about the value of the hay.

The commission will take up the matter again at its January meeting.

If there is a consensus among the members that they want to make changes in the current rules, they would go through the months-long formal rule-making process.

Those steps include public notice, a public hearing, public action and the last stop of presenting the proposal to the Legislature's rules review committee.

Commission member Don Roby of Watertown asked why farmers and ranchers are allowed to hay the public rights of way adjacent to their properties.

The policy means DOT gets the ditches mowed at private expense rather than using tax money.

The commission's rules don't apply beyond state highways. Counties and townships set their own mowing schedules if any.

Benson suggested maybe some party such as the state Game, Fish and Parks Department or sportsmen's organizations would pay landowners to forego mowing. There's got to be a trade-off for the
