DOT, Yankton Co. Seek Input into County Master Transportation Plan Study

The Yankton County Master Transportation Plan study will address a full range of transportation options and issues, including pedestrian, bicycle, transit, freight and automobile. The purpose for the open house is to inform the public of the study's findings and preliminary recommendations and to record any comments or concerns the public may have on those recommendations.

The meetings will be held from 5:30-7 p.m. CST at the location indicated. Don't Restrict Traffic Visibility With Snow

In the city of Yankton, it is illegal for any person to deposit snow or ice at any location in such as manner as to interfere or restrict with the passage or visibility of vehicular or pedestrian traffic. Snow and ice shall not be deposited from private property onto any public street, alley, sidewalk, trail, parking lot or other paved right-of-way with the following exception:

EXCEPTION: Snow and ice may be placed on the following street gutters in the downtown central business district from abutting sidewalks only within the first 24 hours after the snowfall has ended: Third Street from Linn Street to Picotte Street and the following streets for a distance from Second Street to Fourth Street: Broadway, Cedar, Walnut, Douglas, Capital, Mulberry and Pine.

Snow and ice from that portion of a driveway approach in the public right-of-way and public sidewalk may be deposited on right of way areas that are unpaved provided they do not obstruct motorist or pedestrian visibility.

The City of Yankton reminds property owners that public sidewalks are to be kept clear of snow and ice. Property owners who have snow covered sidewalks adjacent to their property need to make arrangements for snow and ice removal within 24 hours after the end of a snowfall. Snow removed from driveways, sidewalks or parking lots cannot be placed in the streets. Contact the City of Yankton at 605-668-5251 for more information.
