District Awards Money For Area Conservation

HURON — Chairman Randy Stanley of Groton announces that the James River Water Development District awarded \$306,378.18 in cost-sharing assistance at their special Board of Directors meeting held in Huron on Thursday, Nov. 19.

The district awarded \$105,000 to the Conservation Districts within the James River Water Development District for 2016 tree planting efforts. Each of the following Conservation Districts will receive \$10,000: Beadle, Brown-Marshall, South Brown, Davison, Hanson, Hutchinson, Marshall, Sanborn, Spink and Yankton.

Aurora County, which is shared with the South Central Water Development District, will receive \$5,000. These funds will encourage producers to plant trees to improve the environment, for example; by protecting the soil, improving water quality and to establish wildlife habitat.

The district awarded \$10,000 to Yankton Conservation District for purchasing a grass seeding drill. This drill will be used to plant all types of grasses and small grains and cover crops in the Yankton County.

The district awarded \$26.250 to Beadle Conservation District to help fund a test site to demonstrate grazing and cropping systems management to improve soil health and water quality. Approximately 600 acres will be used to demonstrate improved grazing techniques and approximately 20 acres will be used to demonstrate cropping techniques that will improve soil health by reducing erosion and runoff, improving organic matter and bring saline soils back into production.

The district awarded \$50,000 to the Town of Dimock in Hutchinson County to help with improvements on its wastewater treatment facilities. The wastewater treatment facility has compliance issues regarding maintaining an adequate depth in the pond and freezing of the influent line in the winter. Correcting this deficiency includes replacement of the existing stream crossing segment of the influent line as well as the installation of an interior dike dividing the deeper section from the shallow section.

The district awarded \$45,000 to Ducks Unlimited to re-construct a breached dam and to restore four wetland basins along Firesteel Creek in Aurora County. The dam provides water for livestock and wildlife and reduces peak flows from entering the Firesteel Creek. The four wetland basins currently drain into the same West Branch Firesteel Creek sub-watershed. These temporarily wetlands are currently in CRP in a field adjacent to the dam reconstruction site and are drained by overland ditches. This project would restore approximately six acres of wetlands by plugging these ditches with compacted soil to restore the original hydrology. The restored wetland basins will provide wildlife habitat, increase water infiltration, and improve water quality in the watershed.

The district also awarded \$2,000 to Ducks Unlimited to repair a dam adjacent to Snake Creek and three miles downstream form Mina Lake in Brown County. This project will repair a headcut that is occurring on the grassed spillway of an earthen dam that impounds about 1.1 surface acres of water. The repair process will be to fill in the headcut with compacted soil, graded to slope, and cover with a LandLock 450 turf reinforcement mat made of UV and biodegradable-resistant polypropylene fibers.

The district awarded \$44,981.18 to a landowner, to build three dams in Walshtown Township in Yankton County. These dams are designed to slow down the water prior to it running through a farmyard and through the Northeast James River Road below the dams.

The district awarded \$23,147 to the United State Geological Survey for operation and maintenance of three stream flow gaging stations on the James River near Stratford, Redfield and Yankton. These funds will provide quality hydrologic data on the James River in a timely and professional manner. Current stream flow conditions can be found at http://waterwatch.usgs.gov/.
