**2. Commercial Rates**

The minimum water charge for commercial meters shall be in accordance to the size of the water meter. The following minimum rates shall be effective with the billings issued after November 1, 2012:

5/8 & 3/4 inch meters - \$13.62; 1 inch meter - \$24.28; 1 1/2 inch meter - \$54.64; 2 inch meter - \$97.08; 2 1/2 inch meter - \$172.43; 3 inch meter - \$218.38; 4 inch meter - \$386.45; 6 inch meter - \$871.00; 8 inch meter - \$1,786.38; 10 inch meter - \$3,084.47; 12 inch meter - \$4,031.17

The minimum monthly charge shall be billed monthly to all commercial water users based on the above effective minimum water rate charge table. The water used in excess of the minimum (2,000 gallons) per billing period shall be charged at a rate of \$3.52 per each additional thousand gallons consumed effective with the billings issued after November 1, 2012.

**3. Non-City Residential and Commercial Rates**

All water sold by the City for either residential or commercial use to any meter location located outside the city limits of Yankton shall be at a rate twice that charged for City water users as established by this resolution unless otherwise established by the City Commission.

**RESOLUTION 12-38**

**WHEREAS,** Chapter 26, Article IV, of the Code of Ordinances as adopted by Ordinance No. 449 and amended by Ordinance 795 for the City of Yankton, establishes the procedure for determining equitable service charges to be levied on all users which discharge wastewater to the Wastewater System operated by the City; and

**WHEREAS,** SDCL 9-40-15.1 requires equitable service charges for all wastewater users; and

**WHEREAS,** it is appropriate to adopt equitable wastewater user rates in order to properly fund the operation of the Municipal Wastewater Treatment System,

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of Yankton, South Dakota, that

I. The following municipal wastewater rates are hereby adopted, effective for bills rendered after November 1, 2012.

**1. Class I - Residential**

a. Shall pay a monthly fixed user charge of \$7.74 per month.

b. Shall pay an incremental cost of \$4.68 per 1,000 gallons based on a monthly average derived from water consumption during the winter period of December, January, and February as billed in January, February, and March; or to a maximum of 5000 gallons where there is no winter base period.

**2. Class II - Commercial and Industrial**

a. Shall pay a monthly fixed user charge of \$7.74 per month.

b. Shall pay an incremental cost of \$4.68 per 1,000 gallons as billed for water consumption.

**3. Class III - Industrial**

a. Shall pay a monthly fixed user charge of \$7.74 per month.

b. Shall pay an incremental cost of \$4.68 per 1,000 gallons as billed for water consumption.

c. Shall pay an incremental cost of \$0.70/lb. BOD5 surcharge (over 220 mg/l strength) and \$0.247/lb. TSS surcharge (over 250 mg/l strength). Said surcharge rates shall be determined based on test monitoring results for the month billed.
