Search Continues For Local Escapee

Authorities were still searching Monday for a 32-yearold male who escaped from the Yankton County jail the previous night.

Yankton County Sheriff Jim Vlahakis said Kai Conrad Hansen escaped from the car port area of the jail facility at 7:02 p.m. Sunday. He is described as 6 feet tall, 225 pounds with brown hair and blue eyes. He was last seen wearing a Yankton County jail jumpsuit with the word "Trustee" on the back.

Hartington Set For A Double Feature

Both Football Teams Host Nebraska Playoff Games Wednesday

HARTINGTON, Neb. — While many towns will be watching to see if their teams advance Wednesday during the second round of the Nebraska high school football playoffs, fans in Hartington (Neb.) will

be seeing double. Both the town's teams will host playoff games that day at the field they share, with Hartington Public (9-0) coming off its first state playoff win to take on High Plains Community (8-1) at 3 p.m. in Class D1 action, followed by the Class C2 matchup of Hartington Cedar Catholic (5-4) vs. Ponca (5-4) at 6:30

"There's two teams from the same town playing on the same field in the same day," said Blair Kalin, Hartington athletic director and head football coach. "That's pretty unique for our town, and it's a good thing for our town.

Kalin and Hartington Cedar Catholic athletic director and head football coach Chad Cattau both said that while unsure, they believe this to be the first time both teams have hosted a playoff game on the same day.

"The community is pretty excited about it, and all the kids are excited about it," Cattau said. "It's definitely something unique, and hopefully both teams can go out and play well having home-field advan-

While both schools and the community are excited about the positives of the doubleheader, the situation requires more planning and work than normal. As they have done before, Kalin and Cattau have teamed up to make sure things

run smoothly. "We work really well together," Cattau said. "We've never had anything come up where we couldn't come to an agreement on something like this. We'll handle it professionally and we understand that it's for the benefit of the kids on all four teams, not just the teams here in town.

He added that despite this likely being the first time the town has hosted a double-

D18 Candidates Eye Economy

How should the state encourage economic development?

District 18 legislative candidates tackled the issue during Monday night's forum at Mount Marty College. The debate included whether the state should set up a Large Project Development Fund that will appear on the ballot as Referred Law 14.

The Senate candidates are Republican incumbent Jean Hunhoff and Democratic challenger Dave Allen. The House candidates are Democrats Bernie Hunhoff — an incumbent — and Charlie Gross and Republicans Mike Stevens and Dr. Tom Stotz.

At Monday's forum, sponsored by the Yankton media including the Press & Dakotan, the candidates approached — and even defined — economic development in different ways.

In the Senate race, Jean Hunhoff pointed to agriculture as a growth industry that accounts for \$825 million in annual exports out of South Dakota. She noted the role of South Dakota State University in ag research and in partnerships between higher educa-
