The County Auditor's role in commission meetings is a supporting role. I act as a secretary, by taking notes and organizing meetings. I also answer any questions and add essential information, as necessarv

5. Yankton County property taxes were not correctly calculated on time a couple years ago after some tragic health issues befell a past auditor. Do you believe safeguards have been put in place to ensure that doesn't happen again, or do you believe any measures should be taken to ensure it doesn't happen again? Paula Jones was a great auditor and we miss her at the office. Her illness was especially debilitating because cancer spread to her brain before diagnosis, affecting her work. I feel this was an extremely isolated case. However, building a strong team approach and cross-training on all tasks is an important safeguard we are currently employing. I'm lucky to work with three great ladies: Karen Farber, Stephanie Janssen and Pat Merkel On a side note, our tax software is reliable and userfriendly. It raises a red flag immediately if something is not calculated correctly at any step in the process. I've also worked closely with the Department of Revenue and other county auditors to ensure we are doing all we can to prevent mistakes.


date David Allen will be on hand to join in the discussion and to offer his insights on the potential effects of the pipeline on the South Dakota environment.


