Remember Yankton's Yard Sign Rules

Yankton ordinance states that election signs and other temporary signs may be posted on private property up to 75 days before an event and must be removed within seven days after.

A good general rule is to keep election signs to the inside (house side) of the public sidewalk or about 15 feet from the roadside curb if there is no sidewalk.

For the safety of all drivers and pedestrians, signs cannot be posted in boulevards, attached to utility poles, street signs, street trees, light poles or be placed in parks.

Signs posted in the public right of way will be removed.
