SIOUX FALLS - Acting United States Attorney Randolph J. Seiler announced that the Disabilities Rights Conference will be held on Wednesday, Oct. 21. The conference will be held at the Sioux Falls Convention Center, located at 1101 N. West Avenue in Sioux Falls, South Dakota. The conference is cosponsored by Avera Health and LifeScape.

In conjunction with the 25th anniversary of the Americans with Disabilities Act, and October's designation as National Disability Employment Awareness Month, the conference is designed to raise awareness about the rights of persons with disabilities, and to educate the public about its role in protecting those rights.


