fits within the box," he said. "The Governor's Office of Economic Development (GOED) doesn't have a program that fits within there, so what we did is, we sat down with Sec. Bergquist and we created a program, for the most part, and it was one of the first applications ever made to the DOT board about two weeks ago.

Morris said that by DOT regulations, the loan had to be made to a governing body, but Dakota Plains is ultimately liable for its payment and not

taxpayers. "Within DOT, their programs that do lend are designed to go through a government entity," he said. "We wanted to be really careful we weren't using any federal money because that would bring a project to a standstill in a heartbeat, so what we did was, we made a request to borrow from DOT as Yankton County, but now we go back to the guiding principle — that being we cannot expose the county to any kind of liability. We went back to Dakota Plains and said, 'Look, we can get this thing going. The TIF is going to pay for itself, it may need some help at times, but the most important thing is we can't expose the county.' So Dakota Plains said, 'We will guarantee that loan from the county should there be any shortfall on that basis."

As a result, the full loan payment will be the responsibility of Dakota Plains alone.

Commission chairman Todd Woods said the prospect of Dakota Plains building at Napa Junction is stronger than ever. "We still have to approve a

developer's agreement (with Dakota Plains), but we're really moving forward at a great pace," Woods said. "They've put their name on the paper with the state DOT. I think we're in a really good position. Of course, until the ink is dry on a piece of paper, something could fall apart, but the indications look very good.'

The developer's agreement with Dakota Plains will be on the county agenda for its Nov. 3 meeting. In other business Tuesday,

"There are so many things that get introduced out there and things move so fast," she

Each day, Ackerman provides sheriffs with a list of bills that have been introduced, including brief descriptions. Law enforcement can then research those bills. The sheriffs then have weekly conference calls with Ackerman to discuss what they think of the bills and how it could positively or negatively impact their counties.

Ackerman takes their input and suggestions to legislators in Pierre.

The first thing I learned is that there is no standard that you have to investigate a bill if you are going to bring it forward," Ackerman said. "A legislator can bring a bill, a concerned group or organization can try and get signatures from legislators and get a bill that way. I try to educate the sheriffs and they give me feedback on what direction they want to

That education gets put to good use. Last year, the association got one local legislator to bring a bill involving medical costs relating to incarcerated inmates. The idea came from officers reviewing laws in other states.

"In Montana, if an inmate has health insurance, the health insurance must pay for it first; then the county picks up the tab," Ackerman said. "It was a very commonsense bill. Before the county pays that medical bill, if the person has health insurance, that should have to pay

Ackerman spends most of her year dealing with these types of legislative issues. The work of the SDSA, she says, is meant to benefit local county governments and also county residents.

"We try to monitor and see how we can make county government, which runs on tax dollars, money," she said.

South Dakota has 66 counties and 26 jails. The counties are responsible for taking care of the prison-

ers. For that reason legislatively, sheriffs are constantly researching and looking at what other states do as far as holding their offenders accountable and keeping costs down.

As a part of that goal, Ackerman is heading back to Pierre next week to meet with the leaders on probation and parole issues.

'Those are a big part of getting those misdemeanors and non-violent offenders out of our jails," she said.

The Juvenile Justice Public Safety Improvement Act was signed into law by Gov. Dennis Daugaard in March. The goal is to encourage discharge of juveniles doing well and to free up court services and officer time to focus on those at a higher risk to reoffend.

In addition to saving money, this reform will also address another problem associated with local law enforcement: jail capacity.

The people we have incarcerated in jail today are more violent than they have ever been," Ackerman said. "It's because we have all these other reforms to get those non-violent ones out."

She mentioned the recent problems with capacity at Minnehaha County jail and its problems associated with adding on to its facilities.

"If they can't get permission to build, they will have to take their prisoners elsewhere," she said. "A lot of the counties that got pushed out of Minnehaha are housing some of their inmates here in Yankton and Vermillion. I don't know of any place that still has space except for maybe some places out of state."

Ackerman stresses that even though the results of the association's work may not always be outwardly visible, it is still important for those that are working toward doing their jobs better.

"I believe very firmly in the office of sheriff," she said. "My dad was the chief deputy in Minnehaha County when I was growing up and he taught me to respect that office. I am very proud to work for the men and — hopefully someday, the women — that are sheriffs out there."
