# **Driver In Crash To Spend 13 Years In Prison**

MITCHELL (AP) — The driver in the crash that killed a 14-year-old boy in Mitchell in June will spend 13 years in

The Daily Republic reports that 23-year-old Karla Martinez was handed a 15-year sentence with two years suspended Tuesday. The Mitchell woman, who earlier pleaded guilty to vehicular homicide, also received credit for 124 days served.

Martinez admitted last month in court that she drank numerous mixed drinks on June 25 before her sport utility vehicle rolled in the ditch off a gravel road west of Mitchell. Records show her blood alcohol level was nearly double the legal limit when the crash happened.

The fatal victim, Lenard Boyer, of Mitchell, was a frontseat passenger and was ejected from the SUV. Three other boys sitting in the backseat suffered minor injuries.

#### **Officials Plead Not Guilty To Embezzlement**

ABERDEEN (AP) - Six current and former Sisseton-Wahpeton Oyate officials accused of stealing more than \$50,000 from the Dakotas tribe have pleaded not guilty.

Carrie Godfrey, Gerald German Jr., Ann German, Calvin Max Sr., Gerald Heminger Jr. and Colette White were indicted by a federal grand jury on Oct. 6. They're charged with conspiracy to embezzle and embezzlement from an Indian tribal organization in connection with a checks scheme that authorities say happened between 2010 and 2013.

South Dakota U.S. Attorney Randolph Seiler says the suspects appeared before a federal magistrate judge in Aberdeen on Oct. 16 and pleaded not guilty.

Each of the tribal officials faces up to five years in prison and a \$250,000 fine if convicted.

### Nebraska Regulators Inspect PP Clinics

LINCOLN. Neb. (AP) — Nebraska regulators have quietly inspected Planned Parenthood of the Heartland's Lincoln and Omaha clinics at the request of Republican Gov. Pete Ricketts.

Nebraska Department of Health and Human Services surveyors visited the clinics in August, the Lincoln Journal Star reported. Omaha clinic director Brenda Harvey said surveyors were interested in speaking with staff who handle fetal tissue.

The visits came after a group accusing Planned Parenthood of illegally selling fetal tissue released videos, prompting congressional inquiries and multiple state investigations this summer.

A department spokeswoman said she could provide little information about the inspections, but confirmed regulators made a similar visit to the Bellevue clinic.

The results appear similar to those of public investigations of Planned Parenthood clinics elsewhere that returned no evidence the organization violated state laws for handling fetal tissue.

Surveyors did threaten both clinics with disciplinary action because of late paperwork, particularly forms with abortion procedure information, which the state required

for statistical purposes. In 2015, the Lincoln clinic missed the due date, the 15th of each month, five times. The Omaha clinic hadn't been on time all year and still hadn't submitted forms for the most recent months. June and July, according to letters from the department's division of public health.

Both clinics are now caught up and the issue has been resolved, said Angie Remington, spokeswoman for Planned Parenthood of the Heartland.

Ricketts spokesman Taylor Gage confirmed that the governor asked the department to look into the issue after the videos' release.

The inspections were not publicly announced before or after they took place.

"It's good to know that DHHS is actually going inside Nebraska abortion facilities and doing some type of investigation," said Julie Schmit-Albin, executive director of Nebraska Right to Life. "That sounds more aggressive than what has happened in the past. I'm glad to hear that (clinic staff) were not notified in advance.

The Lincoln and Omaha Planned Parenthood inspections started Aug. 18.

# **AG Defends Wording On Death Measure**

LINCOLN, Neb. (AP) — The Nebraska attorney general's office is defending language approved for a 2016 death penalty ballot measure.

State attorneys argued in a court filing Tuesday that the ballot language is "sufficient, fair and not misleading." Death penalty opponents have challenged the wording in court, saying it's slanted in favor of the death penalty.

The ballot language informs voters that retaining the repeal law would eliminate capital punishment and change the "maximum" penalty for first-degree murder to life in

Critics say the word "maximum" is misleading because it incorrectly implies that first-degree murder convicts could face a lesser sentence than life in prison.

Nebraska lawmakers abolished the death penalty in May, but the repeal measure was suspended until voters decide the issue next year.

# **HS Band To Perform In DC Parade**

OMAHA, Neb. (AP) — The Omaha South High School marching band will travel to Washington, D.C., next year to represent Nebraska in the 75th Anniversary Memorial Day Parade.

The Omaha World-Herald reports the band launched a fundraising campaign less than two months ago after being selected to march in the parade. The group raised more than \$127,000 after widespread media attention and the launch of an online fundraising campaign.

The band's original fundraising goal was \$90,000. The group received \$40,000 from large donors, but most of the money came from small donations from community members or other high school marching bands. Donations came from all over Omaha, as well as from the rest of Nebraska

"We're just so grateful for the outpouring of support we've received," said Susan Mahoney, school counselor. "When we began this endeavor at the beginning of the year, we had no idea we'd have so many people coming from all over the community to help support the band.'

The band also raised thousands of additional dollars

through car washes and other fundraisers

Band leader Joe Homan said money will go toward the students' buses, hotels, meals and parade entry fees. Nearly 88 percent of students at the high school qualify for free or reduced-price lunch, and many said their families couldn't afford the trip.
