Former Day Care Provider Sentenced

SIOUX FALLS (AP) — A Sioux Falls woman accused of having methamphetamine at an in-home daycare has been

Circuit Court Judge Robin Houwman on Wednesday handed 34-year-old Jennifer Darger a 15-year sentence with 10 years suspended. Darger earlier pleaded guilty to distribution of a controlled substance, possession of a controlled substance and contributing to the neglect of a minor.

Darger and her husband were arrested in March after a tip from her 16-year-old daughter led police to search their home.

Minnehaha County State's Attorney Aaron McGowan had recommended the maximum sentence of 10 years because of Darger's past drug-related convictions and the fact that she was dealing drugs out of the same house from which she operated an in-home daycare.

Darger told Houwman she relapsed after nine years of sobriety because she lost her job.

AG Clears Officer Who Fatally Shot Man

RAPID CITY (AP) — Attorney General Marty Jackley says the Rapid City police officer who fatally shot a man while responding to a domestic assault call was justified in firing his

Á report released Wednesday says 46-year-old Patrick Lundstrom lunged at Officer Matt Macrander with what was later identified as a 15-inch white rod. The report says Macrander fired his weapon the night of Sept. 29 after Lundstrom emerged from a hallway at the unlit home and approached him in a "rapid, aggressive manner" with the metal bar raised over his head.

Two bullets struck Lundstrom, one in the chest and one in the left arm. He was pronounced dead at the scene.

Macrander, who has been a Rapid City officer since 2013, was placed on leave while the state investigated the shooting.

ACLU Urges Supportive Transgender Policy

LINCOLN, Neb. (AP) — The American Civil Liberties Union of Nebraska has written letters to the Nebraska School Activities Association encouraging the organization to draft a policy

that respects transgender students' participation in sports.
The *Lincoln Journal Star* reports the association's board has met in executive sessions to discuss a proposed policy on transgender students, but executive director Jim Tenopir says a vote on a policy is unlikely to happen in November.

Tenopir has met with more than 20 groups, including school administrators, to gather input.

The Nebraska Family Alliance and Nebraska Catholic Conference have told the board that it should require students to play in sports based on the gender on their birth certificate. Former conference executive director Rhonda Blanford-Green introduced a transgender policy two years ago, but it was never enacted. Those who opposed the policy at the time threatened litigation, Tenopir said.

ACLU officials said complaints from transgender students have increased in recent years but noted the situations had been resolved through individual school districts without

Tenopir said that even with a policy by the association, it will be important for all schools to develop a protocol to deal with issues such as locker room and bathroom use.

Penalty Opponents: 'State Won't Get Drugs'

LINCOLN, Neb. (AP) — A group that opposes Nebraska's death penalty says the state won't be able to import lethal injection drugs without violating federal law and exposing itself to additional legal challenges.

The Nebraskans for Public Safety coalition took issue Wednesday with assertions that state officials are working with the federal government to try to obtain the necessary

The group released written comments from University of Nebraska law professor Eric Berger, noting that federal law makes it "very clear" that the drug sodium thiopental cannot enter the country legally for executions.

Berger says states will likely face more difficulty carrying out executions in the future.

Nebraska lawmakers abolished capital punishment in May, prompting a petition drive that suspended the repeal until voters decide the issue in November 2016.

SD Officials Recover Flag

SIOUX FALLS — An original. handmade South Dakota flag dating back to Deadwood's Old West days that went missing from the Secretary of State's office in January has been returned to its home in the state Capitol, Attorney General Marty Jackley said Wednesday.

State investigators recovered the flag, circa 1909, from a former Secretary of State employee on Oct. 8 in Washington, D.C., Jackley told The Associated Press.

He also said criminal charges are anticipated, noting, "I can say that I have been in discussions with a defense attorney, and those are ongoing discussions.

The azure blue and gold flag had been displayed on a stand inside the Pierre office through numerous administrations. Secretary of State Shantel Krebs, who took office on Jan. 2, said an employee who had worked under an earlier administration and was returning to work for her noticed the flag was not there.

"The flag base was there, but not the flag," Krebs said Wednesday.

Krebs said her office conducted a thorough search for the flag before reporting the disappearance to the Department of Legislative Audit as part of a request to audit records and capital assets from the previous secretary of

state, Jason Gant. The audit department re-

ferred the matter to Jackley's office in July, and a probe tracked down the prized possession to the nation's capital. Jackley said his main mission damage or incident, and that Division of Criminal Investigation officials were able to preserve an important part of
