## Charges Pending In Verm. Injury Accident

VERMILION — Charges are pending against an Elk Point man who allegedly caused a two-vehicle injury accident in Vermillion Wednesday.

According to the South Dakota Highway Patrol, the accident occurred at 5:27 p.m. Wednesday at the intersection of Highway 50 and Crawford Road, on the bypass on the east side of Vermillion.

Darren Bret Engle of Elk Point, who was alone in his Jeep

Cherokee, was driving eastbound on Highway 50. He was followed by James Heimsoth of LeMars, Iowa, who was driving a Ford F150 pickup with a trailer pulling a golf cart. Heimsoth's wife, Rita, was a passenger in the pickup.

According to the accident report, both vehicles were traveling in the same direction when Engle went off the road and into the median. Engle came back onto the same road, traveling in the wrong direction, when he struck Heimsoth in a head-on collision.

All three persons were transported to the Vermillion hospital. Engle was transported by helicopter to Mercy Medical Center in Sioux City, Iowa. No further word was available on the condition of any of the three parties.

Alcohol appears to be a factor in the accident, and charges are pending against Engle, according to the report.

The accident remains under investigation by the South Dakota Highway Patrol.
