41-Pound Cat Named Skinny Up For Adoption In Texas

RICHARDSON, Texas (AP) — Don't be fooled by the name: Skinny the cat is one hefty feline. And all 41 pounds of her needs a home.

A Dallas-area animal shelter has cared for the 5-year-old orange tabby since getting a call about a stray in a yard about a week ago.

Kim Chapin with Richardson Animal Services said Friday that Skinny's "very sweet" and the largest cat she's seen in 21 years with the shelter.

Not surprising. U.S. government growth charts show Skinny weighs about as much as the average 4-year-old child.

Chapin says Skinny appears healthy except for being overweight and likely having diabetes. Blood tests have been ordered.

Chapin says somebody apparently had been caring for the cat but officials aren't sure who owned the huge kitty.

that," he said. "Most important is the cost of it. Federal law requires that, after a certain amount of time, those kinds of insurance exchanges must be self-supporting, either through state tax dollars or through charges to the users. Either way, it's a burden on individual South Dakota citizens. We have to evaluate what the total cost would be and what the burden on them would be, and is it worth it to do that? Or should we let the federal government do it and cover that expense themselves?"

Legislation would be required to establish an exchange in the state, according to the Henry J. Kaiser Family Foundation. It has profiled all 50 states' actions regarding health insurance exchanges. The exchanges, which can be set up as government or

non-profit agencies, are intended to provide a more organized and competitive market for purchasing health insurance. They will certify plans and provide information to consumers about their options.

Although states can establish multiple exchanges, only one can serve a geographic area.

If South Dakota intends to create a state-based exchange or a state-federal partnership exchange, it must submit an exchange blueprint consisting of a declaration letter signed by the governor and an application to the U.S. Department of Health and Human Services (HHS) by Nov. 16, the Kaiser Family Foundation states in its report.

Should a state-based exchange not be fully or conditionally operational in accordance with HHS rules by Jan. 1, 2013, the federal government will assume responsibility for running an exchange in the state.

Another element of the ACA that will have to be decided at some point is whether or not to expand Medicaid

"One of the issues that arose after the Supreme Court decision (on the ACA) is, states may, but don't have to, expand their Medicaid eligibility," Daugaard said.

South Dakota currently provides coverage for low-income children and pregnant women, as well as the disabled and some elderly individuals. Daugaard said it amounts to approximately 116,000 recipients.

'We generally do not cover able-bodied adults." he stated. "Even if they are low-income, we insist you take care

The Medicaid expansion would require coverage of certain levels of income regardless of whether or not they've got insurance already," Daugaard continued. "It would add between 40,000-50,000 people to the Medicaid rolls. The federal government would pay all the expenses for a few years, and then it would gradually withdraw some of the support to 90 percent by 2020. The state would then be paying 10 percent of the bill. We have to balance the issue of whether to cover more people, some of whom are without coverage now — so that would argue in favor of extending the coverage — against the increased costs the state

would have to bear over time.' He said there is no immediate deadline to make that decision.

"If we don't do it this year, we could still do it next year," Daugaard said. "It's not a now-or-never kind of situation." Despite being critical of the ACA in the past, Daugaard said there are aspects of it that make sense and citizens

seem to like. "For example, one of the things that's already come into play is the ability of parents to keep their children on the parents' insurance plan up to (age 26)," he stated. "That is a group that is insurable but often not insured. They would be more contributors than claimants under the system because they are young and healthy and don't have a lot of claims. We want to encourage them to be participants so the effect of their participation helps all of us to share the responsibility of adulthood. By keeping them on the parents' plan, you're still going to pay more of a premium by having another participant, but at least they are participating in the global health insurance system.'
