Presentation For Students On Drunk Driving

PIERRE — Attorney General Marty Jackley announced Friday that high school and college students across the state will have an oppor-tunity next week to witness a compelling presentation called "Living Proof," sponsored by Anheuser-Busch wholesalers as part of the company's commitment to fighting underage drinking and drunk driving.

Living Proof" is presented by Sarah Panzau, a two-time member of the National Junior College Athletic Association women's volleyball All-America team. Poor choices can have drastic consequences, but if you learn from your mistakes, the end result can be positive — and Panzau is living proof.

On Tuesday, Pazour will speak at Yankton High School at 10:25 a.m. and at the DakotaDome in Vermillion at 8 p.m. In the early morning hours of Aug. 23, 2003, Panzau's car — and her

life — spun out of control. With a blood-alcohol level nearly four times the legal limit, the 21-year-old decided to drive home drunk, missed a highway exit and rolled her car four times. Without a seat belt, she was ejected through the rear window of her car, her left arm was torn from her body and she was thrown onto the roadway. The next thing she remembers, she was in the hospital being told that she had lost her arm. She remained hospitalized for several months and has endured more than 30 surgeries.

As parents and educators, it is our responsibility to teach young people about the importance of respecting the law and making smart, responsible choices," said Jackley. "Panzau is a powerful speaker and her message should help reinforce our ongoing efforts to combat underage drinking."

Panzau knew what it was like to be on top of her game — and on top of the world. Somewhere between life as a competitively driven high-school athlete and the early years of college, she began heading down a destructive path. She found herself hanging out with the wrong crowd and getting more out of drugs and dangerous levels of alcohol than hitting the books and spiking a ball.

Panzau will recount the pattern of poor choices that finally caught up with her to students at 6 South Dakota schools. The tour is sponsored by Beal Distributing, Conkling Distributing and Ellwein Brothers Distributing

Program Set To Celebrate 60 Years Of S.D. Sports

SIOUX FALLS — SoDak Sports, the popular statewide weekly sports newspaper run by partners Al Neuharth and Bill Porter from 1952 to 1954, will mark its 60th anniversary with a public celebration and refreshments, 3:30 p.m. Wednesday, Oct. 3, at its original office location, the Sid's Crown Liquor Store building in downtown Sioux Falls.

A permanent plaque detailing the creation and eventual failure of the publication will be unveiled on the storefront, 328 S. First Ave. South Dakota native and media icon Al Neuharth and others with connections to SoDak Sports will speak.

Following the program, Paul Damyan, president of Sid's Crown Liquor, will host a free reception honoring his late father-in-law Sid Epstein, who opened the store 65 years ago and rented space to Neuharth and Porter.

The Sioux Falls Area Chamber of Commerce, South Dakota Newspaper Association and the Al Neuharth Media Center at the University of South Dakota are co-sponsoring the commemoration as a tribute to the entrepreneurial spirit, innovation and risk-taking.

In a state that treats athletics seriously, South Dakota newspapers in the early 1950s did a good job with local sports coverage but none was covering the whole state. Enter two recent graduates of the University of South Dakota who had worked together on the student newspaper, The Volante. Al Neuharth and Bill Porter launched SoDak Sports, a weekly newspaper dedicated to covering statewide sports in a new way. The newspaper was a hit with readers, but not with advertisers. Because of insufficient revenue, it folded in less than two vears.

Broke but not broken, Neuharth and Porter went their separate ways and applied the lessons of a failed business to their future endeavors. "You can learn more from failure than success if you're paying attention," said Neuharth, 88, who now lives in Cocoa Beach, Fla.

Neuharth eventually became CEO of Gannett and transformed it into the nation's largest newspaper company. He later founded USA TODAY, the Freedom Forum and the Newseum. Bill Porter pursued a successful legal career, specializing as a defense attorney in medical malpractice, first in Chamberlain and then Rapid City. He died in 2004 at age 78.

are with the contracted electrician that was injured.

Many clients were affected by the disruption to the businesses, Haberman noted.

"The staff and guests did a wonderful job handling the situation," Schmidt said.

Railroad Spikes Cause Flat Tires On Two Vehicles Friday

Railroad spikes at a crossing in southwest Yankton County caused flat tires on two vehicles Friday morning.

The development came a week after the Yankton County Commission publicly excoriated the BNSF Railway for failing to respond to its concerns about spikes coming up at a railroad crossing. "It's one thing not to respond. It's another thing not to do anything about the problem at hand," Commissioner Garry Moore said at a commission meeting last week. "What they are doing is compromising the safety of the motoring public. Second, they are compromising the safety of their trains that pass over that crossing. It's totally irresponsible on the part of Burlington-Northern." Å report was received at 5:48 a.m. Friday that a vehicle had two flat tires resulting from spikes sticking up at a crossing near the intersection of 306th Street and 436th Avenue. A second vehicle

also blew out a tire because of the spikes.

Moore went out himself in recent weeks and pounded spikes back in at a railroad crossing, he told the commission at the aforementioned meeting.

"We shouldn't have to go out as county commissioners and drive spikes in," he stated. "We


