Constitution Day Program Tuesday

VERMILLION — The University of South Dakota will observe Constitution Day on Tuesday, Sept. 17, with a 2 p.m. lecture in the School of Law courtroom by nationally-recognized Indian law expert Professor Frank Pommersheim. The presentation, entitled "Broken Landscape: Indians, Indian Tribes, and the Constitution," is free and open to the public, and students, teachers and professors are encouraged to attend.

The program will provide Pommersheim's latest views on Indian tribal sovereignty under the Constitution and how legal analysis and practice have interpreted and misinterpreted tribal sovereignty since the nation's founding. The Constitution formalized the relationship between Indian tribes and the government of the United States — a re-

through a long history of war and law usurpation — within a federal structure not mirrored in the traditions of tribal governance.

Pommersheim is a widely-respected teacher, scholar, author, poet, and justice on a

number of tribal appellate courts. At the USD School of Law he teaches courses on Indian law, federal jurisdiction, rights of indigenous people, criminal law, and criminal procedure. Pommersheim is currently working on a book with the working title of "Justice in Indian Country: 25 Years as A Tribal Appellate Justice and Tribal Court

Presented at USD by the School of Law, Constitution Day was established by Congress in 2004 to recognize the ratification of the United States Constitution. All colleges and universities that receive federal funding are required to host an educational event about the

for the concept of the park. The conceptual designs were unveiled earlier this week at a quarterly YAPG meeting. It visualizes industrial space, office space, a hotel and a restaurant. Nelson said a roundabout with a target at the center and roads made to look like arrows are some of the ideas with which they have experimented.

At this point, the conceptual renderings represent nothing more than a vision, she noted. No engineering has been done, no businesses are secured it's simply an attempt to visualize the possibilities.

"I think we are limited in our vision only by our imagination," Nelson stated. "Yankton is a world-class community. There is no reason, with the culture of archery we have built and the caliber of leaders we have, that we should not have a worldclass archery park. Without a doubt, we can do that. It isn't going to happen tomorrow, or even next year, but unequivo-

cally, we can do this.' Economic development officials, as well as NFAA representatives, will take the prospectus to major archery conventions to help people in the industry see the possibilities Yankton could hold for them.

"Not only will there be renderings of what could be included as part of the build-out in the prospectus, but it will also have information relating to our infrastructure, development resources and evidence of our community's commitment to archery and archery-related activities," Nelson said. "Marketing should begin immediately and be ongoing. That said, I think our team would be wise to discuss some targeted manufacturers, retailers, etc., that would be good fits in that space.

Cull said one entity that is being approached is Ěaston Technical Products because of the Easton ties to the nearby archery complex.

"Right now, we're working with them to see if there is a potential to do something for warehousing, manufacturing whatever it might be," he stated.

Nelson said YAPG, the NFAA and the City of Yankton will form a strong partnership to promote the archery development park concept.

"Should a lead turn into a more serious prospect, we will collectively work on a proposal, utilizing the knowledge of financing, infrastructure, workforce, engineering, etc., that we have available," she stated.

The Governor's Office of Economic Development (GOED) will also be an important partner, according to Nelson.

The GOED understands that this is a cluster (sometimes called niche) development opportunity for Yankton that absolutely fits in with the State of South Dakota's initiative to capitalize on our appreciation of and commitment to the outdoor lifestyle we value so much in our state," she said.

Cull said officials would like Yankton to be an archery business cluster similar to how the Black Hills is a business cluster for the firearms industry.

Since becoming the city manager at the beginning of the year, Nelson said she has learned that archery is much more than a hobby or competi-

"It is also a significant industry that includes product research, product design and development — not to mention manufacturing and distribution," she stated. "It is a sector of the economy I had not thought about before being exposed to it in Yankton. I am excited about it because I think that it is such a great fit for Yankton and for our state. Not only does it complement existing sectors of our local econ-

omy, but it also opens up so many doors to other related industries."

The conceptual designs have provoked a lot of questions and positive feedback, Nelson said.

"Everyone should keep in mind this is just planting the seed for what could happen on this site," she stated. "It is one idea. I think providing some visuals for people helps to get them thinking. I have a vision for archery, like I have a lot of visions for a lot of things in our community's future. I think that once combined with input from others and tangible prospects, things won't look exactly as I envision. They will probably be
