SUV Hits RC School Bus; 3 Injured

RAPID CITY (AP) — Pennington County authorities say two children were seriously injured when a sport utility vehicle collided with a Rapid City school bus and then hit

The sheriff's office says the SUV spun after hitting the stopped bus and struck the two students who were crossing the street to get on the bus.

A 7-year-old girl and a 10-year-old boy from Knollwood Elementary School were taken to the hospital.

The 17-year-old Douglas High School student who was driving the SUV was also taken to the hospital. The driver has injuries that are not life threatening, but

the two children who were struck are in critical condition. The bus was carrying about 25 kids at the time.

Authorities say neither drugs nor alcohol were likely factors in the crash.

Wounded Knee Landowner Renews Bid

RAPID CITY (AP) — Oglala Sioux President Bryan Brewer plans to meet this week with a Rapid City landowner in what could be a last-ditch attempt to avert the public sale of land at one of the most sacred sites on the Pine Ridge Reservation in South Dakota.

James Czywczynski, 76, is again accepting private bids on a 40-acre parcel he owns in the vicinity of the 1890 Wounded Knee massacre, after months of negotiations with the tribe, KOTA-TV reported this week.

"It's still open to (the tribe) if they want to acquire the property," Czywczynski told the Rapid City Journal. "But it's kind of like first come, first served now.

DUI Testing Pilot Program Coming To Neb.

OMAHA, Neb. — Douglas County offi-

cials will launch a pilot program this fall that will require repeat drunken-driving offenders to take twice-daily blood alcohol tests to remain out of jail while they await trial.

Nebraska officials are modeling the 24/7 Sobriety Program on one that's been in place in neighboring South Dakota since 2005, Nebraska Attorney General Jon Bruning said Thursday.

'More than 30,000 South Dakotans have been through the program," Bruning said. "It's had an excellent efficacy rate, with 6.29 million tests and a failure rate of less than 1 percent. Montana and North Dakota are now trying it, so we think this is something that has the possibility of decreasing repeat DUI cases in Nebraska.

An independent study of South Dakota's program released last year showed that it reduced repeat cases of driving under the influence by 12 percent and domestic violence rates by 9 percent.

The program in eastern Nebraska will give people convicted two or more times

chance to stay out of jail as long as the twice-daily testing shows they have not consumed alcohol. Under the pilot pro-

gram, participants will go to the Criminal Justice Center in Omaha every morning and every night to take a breath

test, and offenders will pay \$2 for each test. The first time a participant tests positive for alcohol, he or she will spend 12 hours in jail. The second time will bring a 24-hour stint behind bars, and a third time will see the offender in jail until a judge decides whether he or she may continue to participate.

Only those awaiting trial will be eligible for the program, said Michael Myers, manager of Douglas County Community Corrections. Judges will make the tests a condition of bond. Those on probation for repeat DUIs will not be eligible for the program during the pilot phase, he said.

We'd rather start small and work out our kinks before we open the floodgates, said Myers, who expects about 200 participants in the Douglas County pilot

program over the next several months.

The program at Sioux Falls, S.D., which has a metro-area population of just under 230,000, sees about 400 participants in the sobriety program every day, twice a day, Myers said. But South Dakota has opened participation to those on probation for drinking offenses, as well as those whose drinking has contributed to domestic abuse charges.

The Omaha metro area has a population of more than 865,000, Myers said, and would see a dramatic jump in the number of people it would have to test if it opens the program beyond those awaiting trial.

Douglas County officials hope to secure grant money to help buy specialized ankle bracelets that monitor alcohol consumption through the skin and would lessen the number of people coming to the center to be tested. They would be available only to those who can show good reason for not being able to go to the center twice a day for testing — such as a work schedule that conflicts with testing hours.

The bracelets automatically alert law enforcement officials if they detect that a wearer has been drinking.


