Presented to the board surplus property from the Sheriff's Office and Jail, discussed replacing the fire sprinkler heads in the County Jail and upgrading the video equipment at the Public Safety Center. Sheriff Vlahakis submitted travel requests for Teri Lippert, Stewart Howell and Greg Jensen.
