The incident occurred at 7:35 a.m. at the intersection of Highway 50 and 451st St. The Yankton County Sheriff's Office has attributed the accident to thick fog that had settled in the area yesterday morning.

Nickles said the fog was enough to hamper their efforts with the accident.

"The fog did make it difficult for responders because it was pretty heavy," he said. "It was slow going to Gayville for the ambulance and fire (department).

# Reported Assault Didn't Pan Out

The Yankton Police Department (YPD)

has released details on an alleged home invasion and assault that turned out not to be the case after investigation.

YPD chief Brian Paulsen said the incident was called in as a possible home invasion and sexual assault based on the information available at the time.

"On Aug. 26, YPD received a 911 call where the caller stated that a home intrusion had occurred," Paulsen told the *Press & Dakotan*. "With the information available to the caller, the possibility was given that a sexual assault had also occurred. Officers and medical staff responded and treated the victim before transporting her to the hospital."

Paulsen said the investigation began immediately, leading to the conclusion that neither a home invasion nor assault

Once the victim was transported to the hospital, officers began the investigation into the events that led up to the call," he said. "Through our investigation, a number of items were discovered that we drew a conclusion that the case was not as it had been reported. The victim confirmed that our investigation was ac-

Paulsen added this is not an unusual occurrence and that they find no fault in the caller for reporting the incident as they initially saw it.

'We don't fault any caller who makes a determination based on what they see and feel at the scene, but in this instance,

the initial report was not what had occurred," he said. "This is not rare in our line of work.

Often, the call officers respond to is not the disposition of the call upon investigation. Our dispatchers do an excellent job of gaining information but can't weigh many factors: emotion, past experiences,

fear from the caller." He added there are no plans to release further details out of respect for the fam-

ily.

"We respect the privacy of the victim and will not expand on the details of our "it is a cold". investigation," he said.

He added the property will also be slated for businesses that may not necessarily be directly related to archery, but help support tournaments.

"When we talk about an archery park, obviously the main theme is to have archery manufacturers and archery-related businesses,' he said. "But along with that archery park is the demand that we're seeing here for related business such as motels, restaurants, retail and whatever may enhance this whole area.

Kramer said his group

will have to continue taking an aggressive approach in order to attract archery-related businesses.

"The more aggressive we are in lead generation, the better it is," he said. "People barely know where South Dakota is, let alone Yankton or that site. The more we get the word out, the better the opportunities. Being as we've owned it less than a year, just to gain interest in the industry would have value to us.

Cull said he sees the process advancing soon.

"We haven't really done more than the administrative part of putting the plan together," he said. "We're about to the point where we're going to move forward. As of right now, there's been a little talk to a few companies, but nothing super exciting yet."

Cull said the goal of the project is ultimately to boost the local economy along with the profile of archery.

"The whole idea is economic development, number one, for the city and state," he said. "From our perspective at the NFAA, it's just the entire promotion of archery. Bringing manufacturers here just makes Yankton more of an archery headquarters both nationally and internationally."


