were there with them. We knew she had passed away when they were living in Yankton, so I came out to the (Yankton) Cemetery and asked if Amanda Pennington was buried here — they said no. I got together with Bernie (Hunhoff) and we did some more checking with the cemetery and they did say that John Pennington had purchased six lots in this cemetery and that lot 1 was occupied — no name, just 'occupied.' Conradi went on to contact

Bishop John Tarrant to help narrow down the search.

"Bishop Tarrant advised me to check with Christ Church in Yankton to see if they have a burial register for 1884, and they did," he said. 'And it showed she was buried in the Yankton Cemetery. Then I got a copy of the Yankton Press & Dakotan from 1884 two days before she was buried, and her obituary was there and it said that she was buried in the Yankton Cemetery temporarily, later to be moved to the family plot in Opelika, Alabama. Í checked with the cemetery in Opelika. Alabama and she was not there — the two infant children (the family lost while living in Alabama) were there, but she was not.

After the search turned up nothing, Conradi was left with only one conclusion and made it a point to remember the late first lady.

We finally came to the conclusion that was the intention of the family — that they would disinter her and move her to Alabama — but it never happened in 1884," he said. "If it would've happened, I think the cemetery records would not show that the grave was still occupied. With that, Bernie and I kind of decided that there needed to be some kind of a permanent remembrance of the wife of a Dakota

His works, assisted by Amanda, were just critical to what we've now become.'

Conradi said he was happy to see a good crowd turn out for the ceremony, noting that Wednesday's unseasonably cold weather almost provided an allusion to the day Amanda

'The ceremony turned out great," he said. "I wasn't sure with the weather — it turned kind of nasty here today. But we had a nice turnout and the (weather) was probably was somewhat typical of what it was back in February of 1884 when she was first put in

Amanda Pennington was the wife of John Pennington, who was a publisher in Alabama during the Civil War. The couple had five children, two of which died during their infancy. During the war, John published articles urging Southerners to accept a peace treaty with the United States. and that stand caught the attention of future U.S. President Ulysses S. Grant, who appointed John the fifth Dakota territorial governor in 1874.

Amanda grew ill and died Feb.7, 1884. The *Press* & Dakotan's obituary read "She conversed freely with her husband and children up to within a few hours of her death, expressing willingness to go and her unswerving confidence in blessed immortality.

Dakota Territorial Museum director Crystal Nelson said it was only right to recognize Amanda's contributions to the community.

"In her years in Yankton, Amanda would've seen a turbulent, yet subtle, town still trying to find its role in a territorial capital," Nelson said. Thus, she should be remembered as one of our community's pioneers — a brave woman who sacrificed, like so many women did here on the wild frontier. Remembering her today is good and proper."

very good carpenter, and he banded the parishioners together and they built the house. It's where Peter grew up.

As an adult, Norbeck started as a well driller and eventually entered politics. A Republican, Norbeck

was the first native son to become governor and U.S. senator for South Dakot. He served as governor from 1917-21 and then as U.S. senator from 1920 until his death in 1936. He lies buried at Bloomington Cemetery, seven miles northwest of Geddes.

Norbeck was the first man ever to drive to the Black Hills by automobile. He promoted a number of progressive causes, fought for protection of the ringneck pheasant, and pushed for creation of Custer State Park Mount Rushmore and the Needles Highway in the Black Hills.

The Norbeck boyhood home was later occupied by other residents, Ackley said. The occupants were moving into a new house in 1988 and wondered if the historical society wanted the Norbeck

home. The society accepted the donation, moving the structure to Geddes. Residents made the restoration their "Lasting Legacy" project for the South Dakota centennial in 1989. However, time had taken its toll on the twostory wood house.

Money is needed to push forward with restoration of the house. The organization also faces deadlines tied to matching funds.

"The last two phases are removing plaster, putting new Sheetrock, and priming and painting the upstairs and the lower level of the home. The 2012 estimate for this work was \$19,500," Ackley said.

'We have a grant from the South Dakota Community Foundation for \$3,000 contingent on the project being completed by Dec. 31, 2014. In order to take advantage of the grant from the South Dakota Community Foundation, we need \$16,000 to complete renovation on time.

She remains hopeful. "Maybe someone will step forward with a large donation," she said.

The estimate for restoring the windows stood at \$11,820, with \$6,671 on hand to cover the cost, Ackley said.

"We have a grant from the Mary Chilton DAR Foundation for \$5.500," she said. "They will pay \$4,500 when we receive an invoice for the windows. We have until Dec. 31, 2015, to finish this portion of the project and receive the last \$1,000.

The Charles Mix County Historical Restoration Society has raised approximately \$3,600 in donations and \$9,200 through fundraisers, Ackley said.

Fundraising produces only one challenge, Ackley said. Finishing the actual restoration has remained difficult. Even those willing to work may find themselves unable to handle the physical labor, she added.

However, the society members and other local residents remain determined to restore the home.

Mount Marty College history professor Rich Lofthus has visited the Norbeck boyhood home. He also spoke at a historical gathering and fundraiser in Geddes.

Lofthus hopes the restoration effort succeeds.

"Given the significance of Peter Norbeck's contributions to the history of the state of South Dakota, restoring the Norbeck home is certainly a worthy preservation project," he said.

"The people of the Geddes area are to be commended for their efforts as they face many obstacles in undertaking this project.

"As awareness regarding their efforts increases, I hope that sources of financial support will be made available to their cause. I would encourage people from our area to visit Geddes to view the progress that has already been made."
