Jensen said Sinclair has been a great addition to the commission throughout his tenure

'Allen is very meticulous in how he does things," Jensen said. "He really researches well and he's been a real asset all those years on the commission. We didn't always agree on things, but that's good sometimes. On things we couldn't agree on, we'd always try to come to a common ground and try to figure it out and make it work.

Additionally, Jensen said Sinclair has done a great job building connections with other entities.

He built a lot of bridges between the city and other entities in the county that we need to work with more and more as partners," he said.
