Prime Time



Learning doesn't begin in Kindergarten, it begins at birth. Long before a child can speak, the acquisition of language skills is taking place. Those language skills play a critical role in the

ability to read. The years between ages 3-5 are prime years for language instruction. They are also prime years for gaining the knowledge needed for future learning.

YSD Preschool FAQs

How old must my child be to attend preschool? Children who are 3 years of age on or before September 1 of the upcoming school year may register for two half-day morning sessions on Tuesday and Thursday mornings. Children who are 4 years of age may register for either three half-day sessions (Mon,

Wed, and Fri AM) or five half-day sessions (Mon-Fri PM).

What are the hours of preschool? T/Th AM: 8:35—11:15 AM M/W/F AM: 8:35—11:15 AM M-F PM: 12:35—3:15 PM How much does preschool cost? T/Th AM = \$80/month M/W/F AM = \$100/month M-F PM = \$140/month Tuition is due on the 1st of every month for September-May. Parents who are eligible for free or reduced lunch may apply for a tuition reduction.

When does registration occur? Registration for the 2015-16 school year will open on Monday, December 1, 2014 at 8:00 AM. Registration will be in the lobby at Webster School.

Is there a registration fee? There is a non-refundable \$50 registration fee to be paid at the time of registration. This is in addition to regular tuition fees.

Does my child need to have immunizations? Immunizations for preschoolers must be up to date.

Does my child need to be toilet trained? All preschool children must be toilet trained prior to beginning preschool at Webster.

Is there preschool bus transportation? Rural, preschool children who are enrolled in the M-F afternoon session will have the option of riding the school bus home after school only.

YSD JrK FAQs How old must my child be to

Who are 5 years of age on or before September 1 of the upcoming school year may register for JrK.

Why should I send my child to JrK? Typically, children

who have a spring or summer birthday are recommended for the program. JrK gives children, who are barely 5 years old, an opportunity to learn in a developmentally appropriate setting while having the opportunity to engage in a variety of learning activities that keep children moving!

Is there a fee for Junior Kindergarten? IrKindergarten does not have a tuition charge, as the students are school age according to SD law.

Is JrK all day or 1/2 day? JrK is an all day, every day program; however, parents can choose a 1/2 day option.

Full Day: 8:35 AM—3:25 PM

1/2 Day: 8:35 AM—11:50 AM

When is registration? Registration for the 2015-16 school year will begin on February 12, 2015 from 4:00-6:00 PM at Beadle Elementary School. Registration is open until school begins in the fall.

Does my child need to have immunizations? Immunizations for JrK students must be up to date.

Is there JrK bus transportation? Rural, JrK children have the option of riding the bus to and from Webster Elementary School.

What grade do kids attend after JrK? Students who complete JrK in the spring will be registered for Kindergarten the following fall.
