

# USD Foundation To Recognize Three During Oct. 9 Reception

VERMILLION — The University of South Dakota Foundation will honor three USD faculty members at a 5-6 p.m. reception Thursday, Oct. 9, at the Neuharth Media Center concourse in Vermillion.

Chris Hutton, JD, is the inaugural recipient of the Cutler & Donahoe Award for Excellence in Legal Education. Jacob Kerby, Ph.D., and David Holdhusen, Ph.D., have been awarded the 2014 Belbas-Larson for Excellence in Teaching Awards.

Hutton has more than 30 years of service to the USD Law School, teaching primarily in the areas of criminal law, procedure and evidence. She most recently co-authored with John Larson, the second edition of South Dakota Evidence. She chairs the State Bar Evidence Committee and was appointed by Gov. Dennis Daugaard to the Criminal Justice Advisory Council. A primary focus of

her work has been teaching and mentoring generations of law students with emphasis on supporting and expanding the role of women in the law.

The Cutler & Donahoe Award was made possible through an endowed gift from the Sioux Falls law firm of Cutler & Donahoe, LLP.

Kerby, who is assistant professor of biology in the USD College of Arts & Sci-

ences, teaches biology, disease ecology and environmental toxicology and contaminants. His research focuses on aquatic communities' stressors. He also serves as director of research for the Missouri River Institute.

Holdhusen is director of choral activities and associate professor of music in the USD College of Fine Arts. He teaches courses in conducting, choral literature and techniques and applied voice.

In addition, he directs USD's annual Choral Directors Institute and the USD Summer Music Camp.

The Belbas-Larson Awards were established by 1956 USD graduate Dean Belbas, Edina, Minnesota, and Harold W. and Kathryn Larson, Bemidji, Minnesota, and Scottsdale, Arizona.

## Nathan List Brings Home First-Place Honor In Shooting Skills Contest

MITCHELL — Earlier this month, one Yankton County 4-H member received first place because of his shotgun shooting skills.

Nathan List was awarded first place in the senior division of sporting clays at the State 4-H Shoot in Mitchell. He competed against 249 other 4-H members from across South Dakota in this event, which is similar to hunting live birds.

"Rather than having clay birds thrown from standardized distances and angles as with skeet or trap, sporting clays courses are designed to simulate the hunting of ducks, pheasants, other upland birds and even rabbits," according to the National Sporting Clays Association website.

Trap and skeet divisions also competed at the State 4-H Shoots.

"We were proud to watch the Yankton County 4-H Shooting Sports team in action," 4-H club leader Randy Hummel said. "The team all shot very well and had a great time at the event."

Participation in the State 4-H Shoot and other competitions is only possible because of donations and sponsorships the club receives, Hummel added.

## Ponca Tribe To Host Open House For New Headquarters

NIORARA, Neb. — The Ponca Tribe of Nebraska will host an open house to celebrate the opening of its new headquarters building from 2-4 p.m. on Saturday, Oct. 4. The headquarters is located along Nebraska Highway 12 in Niobrara.

The new headquarters is approximately 9,000 square feet — more than double the size of the old building, which was located at the same site and had been used for more than 20 years.

The new headquarters will feature a drive-up lane for access, house offices for staff and also include a storm shelter. Nearly 3,000 feet of multi-purpose space also will be included to provide space for tribal and other gatherings. A meeting room and full kitchen will be included in that space.

Following the demolition of

the old headquarters, a Ponca Express Transit Facility will be built. A paved parking lot will be created between the two buildings, and there will be a driveway that connects all roads to the property.

Buffalo Spirit, LLC of Omaha is the general contractor for the project. The company is owned by tribal member Larry Wright Jr.

The Ponca Tribe has a 15-county service delivery area: Boyd, Burt, Douglas, Hall, Holt, Knox, Lancaster, Madison, Platte, Sarpy, Stanton and Wayne counties in Nebraska; Pottawattamie and Woodbury counties in Iowa; and Charles Mix County in South Dakota. Office sites are located in Lincoln, Niobrara, Norfolk and Omaha in Nebraska, and Sioux City in Iowa.
