Father Joe Forcelle and Bishop Paul Swain were present to share their excitement about the addition and lead the group in prayer while sharing readings that highlight the Catholic identity of St. Michaels.

# **Man Arrested After Yankton Shooting**

The suspect is facing four charges of attempted murder, as well as other charges. The South Dakota Division of Criminal Investigation is handling the investigation at the request of the Yankton Police Department because it was an officer-involved shooting.

## Suspect Faces 4 Charges Of Attempted Murder After Officer-Involved Shooting Incident

A suspect in an officer-involved shooting incident in Yankton Tuesday night is facing four charges of attempted murder charges, among others.

Late Wednesday afternoon, a press release from the Attorney General's office announced that the suspect, Trae Allen Angel, 19, Yankton, was being charged with four counts of at-tempted murder (punishable by up to 25 years imprisonment and/or \$50,000 fine for each offense), four counts of aggravated assault against a law enforcement officer (punish-

able by up to 25 years imprisonment and/or \$50,000 fine for each offense) and one count of aggravated assault (punishable by up to 15 years imprisonment and/or \$30,000 fine).

State officials are continuing to investigate

According to a press release from South Dakota Attorney General Marty Jackley, the Division of Criminal Investigation (DCI) has been requested to investigate the incident by the Yankton Police Department. County State's Attorney Rob Klimisch has confirmed the

The Yankton Police Department responded to a 911 domestic disturbance call involving

Upon arrival at the residence, the subject was not located and law enforcement began a search that took more than an hour and involved multiple officers from different agen-

The search ended in an alley in the downtown area, resulting in Yankton Police Sgt. Jason Foote shooting the armed subject. Angel was transported to a local hospital where he is being treated for injuries.

The alley is located between Third St. and Fourth St. (Highway 50) and between Capital and

# **County Holds** First Town Hall

After months of planning, the first in a series of Yankton County Commission town halls kicked off at the Mayfield Bar & Grill Wednesday night with commissioners Don Kettering and Donna Freng.

Freng said the town halls are an effort to hear the voice of the county on major issues — including the looming road and bridge levy election Sept. 29.

"We started these town hall meetings long before we started talking about a levy," Freng told a full room of nearly 20 people. "We wanted to hear more than just the levy, but obviously, that's what's on everybody's mind and we certainly appreciate that's what most of the questions will be about.'

Kettering added the meetings are also about opening up lines of communication with county voters.

'Communication is extremely important," Kettering said. "We need to hear from you guys to know what you're thinking out here. I've been in Yankton County for 40 years and worked with agriculture almost that entire time

#### Leaders To Talk With State About Hilger's Gulch Plan

PIERRE (AP) — City leaders in Pierre say they'll discuss with state officials a plan for changes at Hilger's Gulch park on the South

Dakota Capitol grounds.
The initiative announced by Gov. Dennis Daugaard this summer would replace Kentucky bluegrass in the park with native grasses, trees and shrubs.

Daugaard's goal is to reduce maintenance, chemical use and expenses, but opponents want the park left as it is.

Opponents on Tuesday went to the City Commission. Commissioners say they have differing opinions on the park plan, and they did not make a formal motion to request a meeting with the state. They did agree to talk with state leaders on a less formal level.
