

transported to new waters, even within a small amount of water.

The Omaha District Corps of Engineers is asking residents of the surrounding lake area to be on alert and to take measures to prevent the spreading of the species to other freshwater areas.

"For the folks that are visiting Lewis & Clark Lake, what they will find is increased inspections of watercrafts as they enter and leave by both the state of Nebraska and the state of South Dakota," Grundman said. "That will encourage folks to make sure they are pulling their drain plugs before they leave and not leaving with lake water in their boats and their live wells."

The Omaha District Corps of Engineers is working with other federal, state and local agencies to conduct assessments involving the harm to the hydropower plants. There are several procedures to limiting infrastructure damage such as chemical treatments to increased cleaning.

"The water moves through the system so quickly, we need to figure out where the risks are," Grundman said. "The impacts we see is additional upkeep and would not critically impact

Fortunately, Gavins Point Dam is not an ideal environment for this breed of mussels.

"As far as the lake itself, the substrate isn't conductive for settlement," Grundman said. "Zebra mussels require a hard substrate to attach to. As far of the ecological aspect, it remains to be seen."

The Corps of Engineers will continue to conduct regular maintenance, which usually increases in the winter months. Since the water moves through the system so quickly, extensive research will be essential in discovering high-risk areas.

"This is a cooperative effort with our state partners, Nebraska Game & Parks as well as South Dakota Game Fish & Parks," Grundman said. "It is a joint effort to try to get the education out there and do inspections. Hopefully, we can contain it in this section without having it spread upstream or to other reservoirs."
