

Grant Writing Workshop In Plainview Set

PLAINVIEW, Neb. – The Northeast Nebraska Resource Conservation & Development (RC&D) Council is hosting a one-day grant writing workshop on Tuesday, Oct. 6, in Plainview from 9:30 a.m. until 3 p.m.

Three Nebraska Foundations will be featured and will share information about the goals of their organizations and the types of proposals they like to fund. Nebraska Economic Development will provide details on funding available to help bring projects to fruition. Participants will receive instruction and take-away information on the “Twelve Steps to Writing a Winning Proposal.” This event is an excellent opportunity to start developing a relationship with those that may someday be interested in helping fund a community project and to learn more about developing a

funding strategy.

Lyn Ziegenbein, Peter Kiewit Foundation, served as Executive Director of the Peter Kiewit Foundation, a private foundation awarding charitable grants throughout Nebraska and portions of Iowa and Wyoming, since March, 1983. She now serves as Executive Director Emerita. Ziegenbein served on the Federal Reserve Bank of Kansas City’s Omaha Branch Board of Directors, as an Assistant United States Attorney for Nebraska from 1978 to 1982 and has been a director on many other boards.

Matt Rezac was raised on a small farm in Northern Minnesota with 9 older siblings, some chickens and a couple of skinny cows. He moved home to Nebraska about 4 years ago and is now the Director of Rural Community Partnerships at the Sherwood Founda-

tion. He seeks to help rural communities pass forward the best of the places they call home. He looks for grant investments that leverage local expertise, support local control and foster local resilience.

Jeff Yost joined Nebraska Community Foundation as Vice President in 1998 and was appointed President and CEO in 2003. He has guided NCF’s evolution as an institution that uses philanthropy as a tool for rural community capacity building and economic development. He is a lifelong Nebraska resident and a native of Red Cloud.

able to afford it.

The clinic treats people with illnesses from diabetes to simple colds, and offer maintenance medication. The staff does not do

emergency care.

In addition to taking care of patients physically, the clinic volunteers aim to help patients mentally and spiritually with pastoral care.

“We see if there’s anything we can do to help them spiritually, like if they need someone to talk to or to say a prayer with,” Smith explained. “It’s a holistic

approach of mind, body and spirit.”

The clinic has approximately 80 volunteers on hand, with about 10 of them serving at each session.

The benefits for Smith and the volunteers come from helping those in need.

“It’s amazing to see how many people are stuck between a financial crunch

where medical care isn’t an option for them. We can help provide for them,” said Smith.

Religion In Politics Topic Of Discussion

MITCHELL — Whether or not religion should play a role in politics is the topic of this fall’s McGovern Forum.

The McGovern Civic Engagement Forum will be from 6-8 p.m. Tuesday, Sept. 29, in the Sherman Center at Dakota Wesleyan University. This event is free and open to the public.

“We are seeing more and more policy changes and proposed changes nationwide that involve matters of faith and religious beliefs,” said Dr. Alisha Vincent, director of the McGovern Center.

The theme, “Should Religion Play a Role in 21st Century Politics?” will be debated by the Rev. Barry Lynn, executive director for Americans United for the Separation of Church and State, and Professor Rena Lindevaldsen, interim dean and professor and associate director of the Liberty Center for Law and Policy, Liberty University.

DWU students will work with the McGovern Center to design four questions that the candidates will cover.

“These questions will relate to the topic and feature an issue that is appealing and relevant to audience interests, such as whether prayer should be allowed in public schools,” Vincent said.

Audience members will have an opportunity to write in a question and present it to the room moderator.
