as to what additional costs might be incurred based on those alternatives."

Nelson said there are a few reasons behind the rise in cost estimates.

'The estimates were made about three years ago, so there's some cost impact there," She said. "We also know more about the collector well and the water quality. The water quality is different than we estimated and is higher in dissolvible solids than we thought, which requires more facilities to treat."

She added there will also be more water to treat, thus boosting the city's water capacity.

"The good news is we also think there's going to be more water passing through than we initially thought," she said. "As we pump more, the water quality, we under-

stand, is going to improve ... Putting more equipment in initially will treat the water that we need it to and eventually is going to treat more water, giving us a little more longevity.'

Initially the plant was estimated at around \$18 million.

Nelson said the total cost is going to depend on the commission's direction in

the coming months. "It depends upon what types of design elements they would like to pursue," she said. "We have the opportunity to add some redundancy because we have more water from the collector well than we initially thought we would have, and that's a good and a bad thing - we're going to have more capacity, but at the expense of having more equipment."

Additionally, there are also opportunities for building enhancements including aesthetics and additional office and garage space, allowing the city to vacate the 1929 water plant for other

purposes.

Nelson said they're still discussing how best to raise the additional money and the factors they'll have to watch.

"We talked a little bit about rates," she said. "We talked about putting additional costs on the surcharge. The customers will remember that's how we put forward for our first improvements — our collector well, our raw water main and what we thought were going to be the expenses for the water treatment plant — were primarily on the surcharge and some on the rates. We also talked about putting the increase on rates. Part of that depends on what the state revolving loan fund allows and how we can charge that back down to the customer."

She added that the rates will be decided at a later date.

"We'll talk about that closer to when we choose and bid out the alternatives," she said. "There will be a

rate increase — what that will look like, we're uncertain at this point."

Nelson said the commission ultimately wants to get the project done in the correct manner.

"I think the general consensus was we really want to get the plant built correctly the way we like the first time," she said. "The commission, in general, would like to see as much redundancy and capacity as we can put into the plant, as well as architectural enhancements because of where it is and the efficiency to have everything in one

location. Nelson said more discussion on the matter is expected in October with bidding planned for the spring of 2016.

No official action was taken at Monday night's meeting.

 On September 15, 2015 at 6:37 p.m. the Knox County Sheriff's Office received a 911 call reporting that a bicyclist had been hit by a semi about a half mile east of the Blue Moon turn-off on Highway 12 and that the semi driver did not stop to help the bicyclist. The Knox County Sheriff's Office and Niobrara Fire and Rescue responded to the scene. Ultimately a semi owned by K&J Trucking from Sergeant Bluff, Iowa was located parked at the Argo Hotel in Crofton. The semi was being driven by Gerald Rains of Sioux City, Iowa. An inspection of the passenger's side of the semi performed and honey was located in several areas on the truck. The driver was questioned about the incident. Evidence was collected from the semi and the driver was released pending an evidence comparison from the semi

The next day Gerald Rains contacted the Knox County Sheriff's deputy investigating the accident and confessed to the crime. Rains was cited, and will appear in the Knox County Court in October.
