# **Pope Makes First Address To Congress**

WASHINGTON — Wading into bitter disputes, Pope Francis urged a divided Congress and America on Thursday to welcome immigrants, abolish the death penalty, share the nation's immense wealth and fight global warming. Lawmakers gave rousing ovations to the leader of the world's Catholics despite obvious disagreements over some of his

After he addressed Congress, the first pontiff ever to do so, he underscored his message by traveling directly to a downtown Washington church where he mingled with needy and homeless people, blessed their noontime meal

and walked among them as they were eating.
Soon after, he was off to New York, second stop on his three-city first visit to the U.S. He addresses the U.N. on Friday and winds up his visit this weekend in Philadelphia.

At the Capitol, the remarkable sight of the pope speaking in the House chamber seemed to delight lawmakers of all persuasions, though he offered an agenda more to Democrats' liking. Besides his focus on climate change and immigration, he denounced arms sales and seemed to allude approvingly to the Iran nuclear deal and recent Obama administration actions to open relations with Cuba, done with his urging.

Republicans, too, heard something to like in his references to the sanctity of life and family relations, reminders that even the more open Catholic Church Francis presides over still condemns abortion and gay marriage.

For all the spectacle, it seemed unlikely the pope's visit would break congressional inertia on the issues dear to him, with no action in sight from the GOP majority on global warming or immigration.

But Francis, in his historic speech, seemed determined to remind the United States of its foundations as a country made up of foreigners, addressing the chamber and the American people beyond in personal terms as a son of immigrants to "this great continent."

We must resolve now to live as nobly and as justly as possible as we educate new generations not to turn their back on our 'neighbors' and everything around us," he said. "We must not be taken aback by their numbers but rather view them as persons, seeing their faces and listening to their stories, trying to respond as best we can to their situa-

After the address, Francis appeared high on a Capitol balcony and briefly addressed a cheering crowd of thousands below on the lawn and the Mall beyond who had watched his speech on giant TV screens. "Buenos dias," he called out in the language of his native Argentina and millions of U.S. immigrants, legal and not.

The crowd thundered its response.

Francis asked the crowd to pray for him, as he always does. But speaking in Spanish, he added a line to acknowledge that not everyone there was a believer. "If among you there are some who don't believe or who cannot pray, I ask that you send good wishes my way," he said, to tumultuous

"God bless America!" he concluded, as he had in the House chamber.

#### Bus Collides On Busy Bridge, 4 Killed

SEATTLE (AP) — A "duck boat" tour vehicle and a charter bus carrying foreign students to a college orientation event collided on a busy Seattle bridge Thursday, killing four people and sending dozens to hospitals.

The collision happened on the Aurora Bridge, which carries one of the city's main north-south highways over a lake. At least eight people were in critical condition, and many others suffered lesser injuries.

There was no immediate word about the cause of the crash, which involved a military-style tour bus that can also be operated on water. Initial reports described the accident as a head-on collision.

We didn't see anything. Just the sound. The smell of gas," said Rujia Xie, a 16-year-old from China, who was on the bus carrying about 45 North Seattle College students and staff. The group was headed to Safeco Field as part of new-student orientation programs.

She said glass fell on their faces, and some people jumped from the bus.

#### McConnell Offers Bipartisan Bill

WASHINGTON (AP) — The Senate's top Republican moved swiftly to avoid a government shutdown in six days, pushing legislation that would keep agencies operating without a contentious fight over money for Planned Parent-

The action of Majority Leader Mitch McConnell, R-Ky., followed a decisive Senate vote blocking a bill that would have stripped Planned Parenthood of its taxpayer funding while keeping the government running through Dec. 11.

The vote was 47-52, falling short of a majority and well shy of the 60 votes required to overcome a filibuster led by Democrats. Eight Republicans, several of whom support abortion rights, voted with 42 Democrats and two independents to kill the measure.

McConnell immediately offered a bipartisan stopgap spending bill free of the Planned Parenthood dispute that's expected to easily clear the Senate next week by a wide bipartisan margin. He has for almost a year promised that Republicans controlling Congress won't repeat the government shutdown of two years ago.

In the House, GOP leaders called a meeting of their fractious rank and file for Friday morning to discuss whether to accept the Senate's move or reject it at the risk that continuing the fight over Planned Parenthood would lead to a government shutdown.

### In Crowds Of The Hajj, Deaths Build Fast

NEW YORK (AP) — When too many people are squeezed into too small a space, the situation can turn dangerous very quickly, experts say. And that, they say, may be key to understanding the deaths of more than 700 pilgrims on the outskirts of Mecca.

"It's largely a physical phenomenon, not a psychological one," says Dirk Helbing, a professor of computational social science at ETH Zurich, who has studied crowds and disasters.

When the density is too high, movements of a body "transfers forces to other bodies. These forces can add up and create uncontrollable movements in the crowd," he said Thursday.

'As a result ... people might fall on the ground and might be trampled by others" or die of suffocation as others fall on top of them, he said.

And it can happen fast. Even a small incident like two people starting a fight or trying to walk against the crowd can quickly snarl a free-flowing crowd in large-scale congestion, he said. As more and more people pour in, the density builds up, setting the stage for lethal turbulence.

#### **President Creates Special Prosecutor**

MEXICO CITY (AP) — President Enrique Pena Nieto told the families of 43 students who disappeared a year ago in southern Mexico during a meeting Thursday that he would create a new special prosecutor for all of the country's thousands of missing people.

Eduardo Sanchez, the president's spokesman, told reporters after the closed-door meeting that the families had presented eight demands and that Pena Nieto had instructed his Cabinet to analyze each and get back to them.

More than 25,000 people have disappeared in Mexico between 2007 and July 31, 2015, according to the government. The students' disappearance on Sept. 26, 2014, brought the issue back into the spotlight.

Among the families' demands are a new internationally supervised investigation of the disappearances and an investigation of into those responsible for the initial inquiry, which the families believe was intended to mislead them.

Sanchez said after the meeting that there was not a clear timeframe for when the demands would be answered, but that it would be done promptly.

#### **Efforts To Build Ties Yield Mixed Results**

WASHINGTON (AP) — President Barack Obama has invested more time building personal ties with Chinese President Xi Jinping than with most other world leaders. But as Xi arrives in Washington late Thursday for a grand state visit, it's clear that Obama's overtures have produced decidedly mixed results.

During intimate walks and hours of private discussion around the world, Obama and Xi forged a historic breakthrough to combat climate change and collaborated on efforts to curb Iran's nuclear program. But there's been little progress on a pair of vexing security issues that will be at the forefront of their latest round of discussions: China's cyberspying in the U.S. and its disputed territorial claims in the Asian Pacific.

"The assumptions that many people had, that cooperation on transnational threats like climate change would ameliorate problems in geopolitical arenas were wrong, said Michael Green, White House Asian Affairs director under President George W. Bush and current senior vice president at the Center for Strategic and International Studies.

Before plunging into the pageantry of the state visit, Obama and Xi met for dinner Thursday night at Blair House, the guest residence steps from the White House. They were joined by Vice President Joe Biden, who has also played a central role in building the administration's relationship with the Chinese leader. Secretary of State John Kerry and National Security Adviser Susan Rice were also on hand for the informal dinner, where both world leaders ditched their ties.

Biden greeted Xi when his plane touched down at a military base near Washington.

## **Woman Gives Birth To Baby On Cruise**

SALT LAKE CITY (AP) — A Utah woman who unexpectedly gave birth on a cruise ship months before her due date says she wrapped towels around the 1 1/2-pound boy and, with the help of medical staff, managed to keep him alive until the ship reached port.

Emily Morgan, of Ogden, said Thursday that doctors didn't expect her son Haiden to live, but thanks to strong lungs, a makeshift incubator and an early arrival in Puerto Rico, the baby made it. He's now receiving care at a neonatal intensive care unit in Miami.

Morgan, 28, said the baby was due in December but contractions began Aug. 31 during a seven-day cruise around the eastern Caribbean. Her doctor approved the cruise to celebrate her daughter's third birthday, Morgan said.

The pregnancy had been uneventful, so she was shocked when the contractions began just past the halfway mark in her pregnancy. She thought they might be false labor.

But she and her husband called medical staff when they saw blood. A doctor aboard the Royal Caribbean ship told her she couldn't give birth because they were still 14 hours from the nearest port in Puerto Rico. But holding back wasn't an option, Morgan said.
